#### **DISCUSSION:**

The South Nation Conservation (SNC) Forest Annual Report (attached) summarizes activities that occur within the SNC Forest during the annual operating period January 1, 2022 to December 31, 2022.

Highlights of the current Annual Report include:

- An increase in the forest area of 103.8 hectares (six new acquisitions)

#### **1** INTRODUCTION

South Nation Conservation (SNC) owns land including forests and wetlands. These lands are managed in accordance with an approved forest management plan which provides for sustainable timber harvest that generates revenue, improves forest health, provides wildlife habitat, protects natural heritage, and creates recreational opportunities. As of December 31, 2022, the total area of land owned by SNC was 5,038.1 hectares.

This report outlines the administrative and operational activities that have been carried out from January 1, 2022, to December 31, 2022.

#### 2 FOREST ADMINISTRATION

#### 2.1 Forest Accruals and Depletion

Under the Forest Land Acquisition Program, SNC actively seeks to acquire land for forestry purposes and ensure adequate forest cover throughout its jurisdiction. In 2022, four parcels of land were added to the SNC Forest, and two parkland properties were acquired. There were no depletions in 2022. The forest area at the end of the operating period was 4,847.0 hectares. Table 1 provides a summary of changes to the SNC Forest land base.

#### 2.2 Forest Certification

The SNC Forest maintained Forest Stewardship Council (FSC) certification during the operating period under Group Certificate RA-FM/COC-000232. The annual FSC audit was completed from October 22, 2022 to October 31, 2022. Four Community Forests, one private commercial forest owner and five private forest owners were included in the 2022 audit. Member-forests are randomly subject to audit following internal monitoring requirements as per the new Group Standard (FSC-STD-30-005V2-0 FM Groups Standard). SNC submitted all documents required for independent annual audits under group certification but was not selected for field audit during the 2022 operating period. Non-conformities and observations apply to all group members where applicable.

During the FSC audit, two minor non-conformities and one observation were reported. Minor non-conformities were:

#### 1. Minor Non-Conformity Report (NCR) - Standard 4.2.1/23

Auditor observed first aid kits were missing from 2 forestry machines involved in active operations (processor-buncher & forwarder) involving one contractor at one site visited. EOFG policy and harvest contracts state workers need to abide by all occupational health and safety regulations and safe practices. This would include first aid kits being readily accessible.

#### 2. Minor Non-Conformity Report (NCR) - Standard 2.1/23

Memorandums of Understanding (MOUs) have been signed with all members however they do not fully encompass the requirements from subsections b and d, specifically there is no statement or consent declaring 'that the management units they are bringing into the group are not included in another FSC certificate' and though the MOUs refer to EOFG employees and contractors, explicit wording regarding the group member agreeing to allow 'the certification body, FSC and ASI to fulfil their responsibilities' is lacking. Forest owners/managers interviewed understood aspects a-d) and have given their consent.

#### 3. Observation 4.2.1/21

The Auditor observed that group members were compliant with requirements for monitoring and reporting species at risk (SAR) and rare/uncommon species but noted that each member implements this slightly differently. This will be reviewed by the Group coordinator.

The SNC Forest was not subject to internal activity assessments conducted by the Group Certificate holder (EOMF).

The Annual Reporting Form was submitted to the Group Certificate holder (EOMF) on July 28, 2022. The annual report indicated for the period July 1st, 2021 to June 30th, 2022 an annual harvest volume of 717.39 m<sup>3</sup>, 120.97 hectares added to the forest and no area removed from the forest, and a total forest area of 4,492.87 hectares.

#### 2.3 Property Tax Programs

2.3.1 Managed Forest Tax Incentive Program (MFTIP)

In 2022, an amendment to the Managed Forest Tax Incentive Program was submitted adding recently acquired properties under Plan No. H9816.

Plan No. H9816 was accepted to the MFTIP under Ontario Regulation 282/98 of the Assessment Act on September 10th, 2018.

2.3.2 Conservation Lands Tax Incentive Program (CLTIP)

In 2022, twenty compartments within the SNC Forest had areas eligible under the Conservation Lands Tax Incentive Program (CLTIP) and voluntarily registered under CLTIP for the 2023 tax year. The total area was 620.8 hectares. These properties are all Provincially Significant Wetlands (PSW) and /or Areas of Natural & Scientific Interest – Life Sciences (ALS).

#### 2.4 Easements

2.4.1 Ontario Heritage Trust (OHT)

The SNC Forest contains 623.04 hectares subject to Heritage Conservation Easement Agreements (HCEA) to the interest of the Ontario Heritage Trust (OHT).

Under the terms of the HCEA, the SNC Forest can be subject to a compliance audit by an OHT representative. There were no audits completed in 2022.

#### 2.4.2 Utility Easements

Several forest properties are subject to utility easement agreements registered on title. Table 6 provides a list of affected properties. Regular maintenance activities are conducted by the easement holder. The easement holder coordinates these activities with the SNC Forest manager. Forest operations may be restricted by the easement.

One new easement was registered for SNC79 on December 20, 2022, under instrument PT71233 to the interest of Hydro One Networks Inc.

#### **3 FOREST MANAGEMENT**

#### 3.1 Twenty-Year Forest Management and Five-Year Operational Plan

The Forestry Committee reviewed the Twenty-Year Forest Management Plan and Five-Year Operational Plan and recommended the plans to the Board of Directors in March 2018 subject to final comments until March 15th, 2018. The Board of Directors approved the plans in June 2018 (BD-119/18). There were no changes to the Twenty-Year Forest Management Plan and the Five-Year Operational Plan during 2022.

#### **4** FOREST OPERATIONS

#### 4.1 Silvicultural Prescriptions

Silvicultural prescriptions were prepared for operational activities on seven SNC Forest properties for a gross total area of 142.4 hectares. Silvicultural prescriptions consisted of mainly conifer plantation thinnings. Table 2 summarizes the prescription activities.

#### **DISCUSSION:**

The SNC Forest Operating Plan for 2024-2028 includes a summary report of past forest operations and activities for the 2018-2023 period and sets forth a schedule of planned activities for the next operating period (2024-2028).

The report of past forest operations and activities includes the following sections:

- Forest accruals and depletions;
- Harvest summary;
- Forest certification;
- Invasive alien species control and monitoring;
- Maple syrup operation;
- Seed forecasting and collection;
- Tree planting;
- Capital projects and infrastructure;
- Biological control and climate change adaptations responses to major events; and
- Ecosystem services improvement projects.

Regarding the selection of harvest areas, there are a total of 18 compartments from the 2018-2023 plan to be deferred to the 2024-2028 plan. Additionally, the LiDAR data delivery, expected to be received this year, will provide essential information for the selection of the harvest areas. Once received, staff will study the data and proceed with verifications in the field.

The 2023 schedule for the Plan is as follows:

- Draft Review (September)
- Final Review (December)
- Board Approval (December)

The 5-year Operating Plan Draft will be circulated to the members of the Committee prior to the September meeting.

#### **RECOMMENDATION:**

The Forestry Committee receive and file the 2023 Tree Planting and Free Tree Days update.

#### **DISCUSSION:**

This spring South Nation Conservation (SNC) had another successful tree planting season which included the planting of 82,270 trees through the Forests Ontario Program (50 Million Tree Program), 77,200 trees at Larose Forest, and 38,260 trees sold through the Over-the-Counter program.

The planting season lasted 31 days over April and May. For the fourth year, SNC enlisted staff to plant 25,270 trees on 30 properties for the Forests Ontario Program. Staff completed the planting over a 4-week period. A list of 2023 customers per municipality is attached.

In total, 34 landowners across SNC's jurisdiction and in the United Counties of Prescott Russell planted a new project through the 50 million Tree program in spring 2023. These sites will attribute to an estimated 75 acres (890 per acre) of increased forest cover in the future.

SNC currently has 1,500 trees reserved for spring 2024 by 5 landowners, with over 50 landowners on the wait list for a summer 2023 site visit for spring 2024 planting.

For the fifth year in a row, SNC offered municipalities free tree seedlings as part of the 2023 Free Tree Days. Each member municipality was supplied with 380 tree and shrub seedlings consisting of 10 native species. There have been 15 giveaways totalling over 7,500 trees including a tree giveaway to nurses and healthcare workers at the Winchester and District Memorial Hospital, the Glengarry District Memorial Hospital, and the Cornwall Community Hospital.

Over 2,500 residents throughout the jurisdiction applied for this years Free Tree Pick Ups. Approximately 80-150 households in each municipality received a bundle of 5 tree seedings based on their indicated species preference. Pickups were held at a central location in each municipality and took place throughout the month of May.

Compliance with Budget: The tree planting program is included in the 2023 Budget under Resource Management, Partner Programs, Forests pages 16-17.

SNC Policy Adherence: SNC Forest Policy 2 and 3: The South Nation Forest shall be managed to provide a range of products and services that will maintain or enhance the long-term economic viability and a range of environmental and social benefits; and South Nation Conservation will employ sylvicultural practices that are ecologically appropriate for the vegetation, species, sites and management objectives that maintain and/or enhance long-term forest diversity, health and productivity of the South Nation Forest.
