DISCUSSION:

In 1992, a Conservation Strategy was undertaken by SNC to produce a Conservation Authority Plan for the 21st Century: Vision 2020.

With a need for renewed reflection and visioning, SNC has initiated a strategic planning process to position the Authority *Beyond 2020* as we encounter a changing landscape, climate, and shifting economic and environmental dynamics.

To kickstart the 2019 strategic planning process, SNC Committee members participated in an interactive two-step exercise to reflect and visualize future direction of programs and services offered by SNC at the March Joint Committee Meeting.

Key areas of focus identified by Committee Members for *Beyond 2020* are summarized below:

- Environmental Stewardship Advocacy and Public Program Support
- Forest Conservation Programs
- Improved Planning and Approvals Process
- Expand Recreation and Program Partnerships with Municipalities, Community Groups and Tourism Organizations
- Invasive Species Program Outreach
- Water Quality Program Improvements
- Training Centre Development

Committee members are encouraged to provide individual and group feedback on SNC Programs and Services through their respective Committee Chair and staff lead.

Committee members are also encouraged to review SNC's response to provincial budget and program changes: "Conserving What We Value".

Through understanding the needs of communities and environment SNC's work, now and future, will improve and create valued programs and services.

Committees are tasked with creating a list of future actions to be considered, supported by community environmental values.

DISCUSSION:

Bill 108, More Homes, More Choice Act, 2019

Currently in second reading in the Legislative Assembly of Ontario and includes proposed legislative changes to the Conservation Authorities Act, including proposed changes from the following environmental registry postings which closed on May 21, 2019.

1. Modernizing Conservation Authority Operations: Conservation Authorities Act (MOECP)

Proposes to introduce amendments to the Conservation Authorities Act, which if passed, focuses a core mandate for Conservation Authorities and improving governance.

Summary of proposed changes:

- Define core mandatory programs and services provided by conservation authorities to be: natural hazard protection and management; conservation and management of conservation authority lands; drinking water source protection (as prescribed under the Clean Water Act); and protection of the Lake Simcoe watershed (as prescribed under the Lake Simcoe Protection Act);
- Increase transparency in how conservation authorities levy municipalities for mandatory and non-mandatory programs and services;
- Update the Conservation Authorities Act an Act introduced in 1946, to conform with modern transparency standards by ensuring that municipalities and conservation authorities review levies for non-core programs after a certain period of time (e.g., 4 to 8 years);



- Establish a transition period (e.g. 18 to 24 months) and process for conservation authorities and municipalities to enter into agreements for the delivery of non-mandatory programs and services and meet these transparency standards;
- Enable the Minister to appoint an investigator to investigate or undertake an audit and report on a conservation authority; and
- Define the duty of conservation authority Board Members is to act in the best interest of the conservation authority, similar to not-for profit organizations.

Proclaim un-proclaimed provisions of the Conservation Authorities Act related to:

- Fees for programs and services;
- Transparency and accountability;
- Approval of projects with provincial grants;
- Recovery of capital costs and operating expenses from municipalities (municipal levies);
- Regulation of areas over which conservation authorities have jurisdiction (e.g., development permitting);
- Enforcement and offences, and
- Additional regulations.

2. Focusing Conservation Authority Development Permits on the Protection of People and Property (MNRF)

Proposes a regulation that outlines how conservation authorities permit development and other activities for impacts to natural hazards and public safety. The proposed regulation would make rules for development in hazardous areas more consistent to support faster, more predictable, and less costly approvals.

The Ministry is proposing to create a regulation further defining the ability of a conservation authority to regulate prohibited development and other activities for impacts to the control of flooding and other natural hazards.

This regulation would replace Ontario Regulation 97/04 which governs the content of conservation authority regulations under the current Section 28(1) of the Act, as well as all existing conservation authority regulations (O.Reg. 42/06, O. Reg. 146-148, O. Reg. 150-153, O. Reg. 155-172, O. Reg. 174-182, and O. Reg 319/09).

Consolidating and harmonizing the existing 36 individual conservation authority-approved regulations into one Minister of Natural Resources and Forestry approved regulation.

For the purposes of this regulation the Ministry is also proposing to:

• Update definitions for key regulatory terms to better align with other provincial policy, including: "wetland", "watercourse" and "pollution";



- Define undefined terms including: "interference" and "conservation of land" as consistent with the natural hazard management intent of the regulation;
- Reduce regulatory restrictions between 30m and 120m of a wetland and where a hydrological connection has been severed;
- Exempt low-risk development activities from requiring a permit including certain alterations and repairs to existing municipal drains subject to the Drainage Act provided they are undertaken in accordance with the Drainage Act and Conservation Authorities Act Protocol;
- Allow conservation authorities to further exempt low-risk development activities from requiring a permit provided in accordance with conservation authority policies;
- Require conservation authorities to develop, consult on, make publicly available and periodically review internal policies that guide permitting decisions;
- Require conservation authorities to notify the public of changes to mapped regulated areas such as floodplains or wetland boundaries; and
- Require conservation authorities to establish, monitor and report on service delivery standards including requirements and timelines for determination of complete applications and timelines for permit decisions.

Once established, the province is also proposing to bring into force un-proclaimed sections of the Conservation Authorities Act associated with conservation authority permitting decisions and regulatory enforcement.

South Nation Conservation worked with Conservation Ontario and other Conservation Authority's on feedback for formal submission. Staff shared letters of endorsement to local MPP's, member Municipalities, First Nations, and partner organizations seeking support and feedback on the postings.

Subject: In response to the April 5th, Ministry of Natural Resources and Forestry's posting number 013-4992 on the Environmental Registry of Ontario; 'Focusing conservation authority development permits on the protection of people and property'.

Dear Minister Yakabuski,

The <<*insert municipality name>>* has a strong history of close collaboration with South Nation Conservation (SNC) on shared priorities, which protect the environment and engage communities while balancing people and nature.

SNC has a streamlined, convenient and pragmatic approach to local regulation and permit approvals that adhere to their environmental mandate of protecting people and property from natural hazards; including:

- Delivering municipal watershed planning reviews on behalf of member municipalities to determine if development is susceptible to natural hazards.
- Offering pre-consultation meetings to review development proposals with residents, municipal staff and developers, leading to more efficient approvals.
- Delivering cost-effective municipal programs through memorandum of understanding agreements, including issuing permits and performing inspections for septic installation and maintenance on behalf of 13 participating municipalities under Part 8 of the Ontario Building Code.
- Preparing floodplain maps and updating regulated areas for municipalities to guide official plans and zoning by-laws, and guide future development away from flood and erosion-prone areas; SNC holds public open houses and communicates directly with residents to inform updated mapping.

Subject:	Update: Fisheries Act Amendments	

RECOMMENDATION: The Board of Directors receive and file the update report on *Fisheries Act* Amendments.

DISCUSSION:

On February 6th, 2018 Fisheries and Oceans Canada (DFO) introduced proposed amendments to the *Fisheries Act*. Essentially, the proposed amendments are to restore environmental protections that were changed in June 2012.

The following table summarizes the before and after implications associated with amendments to the *Fisheries Act* (table information taken directly from DFO website):

Further amendments and opportunities to be created from the proposed changes include:

- Increased transparency and consultation for projects that interfere with fish and fish habitat through the creation of an online project registry.
- Enhanced enforcement and monitoring of projects: DFO has advised SNC that there will be a new group of DFO staff established to directly deal with potential cases of harm to fish and fish habitat.
- The ability to establish standards and codes of practice for the avoidance of the death of fish and harmful alteration, disruption and destruction of the fish habitat, the conservation and protection of fish or fish habitat, and the prevention of pollution.
- The establishment of a new system for project proponents to create fish habitat banks in exchange for habitat credits to offset a project's adverse effects on local fish and fish habitat.

To date, the amended Fisheries Act has passed its Second Reading in the Senate and



was referred to the Standing Senate Committee on Fisheries and Oceans December 11, 2018.

SNC will continue to advocate for local delivery of this program, in the most timely and cost-effective manner.
