DISCUSSION:

The Board of Directors approved negotiating a renewal of the Camp Sheldrick Management Agreement expiring on June 30, 2020 (BD-027/20). The new agreement has been updated and reviewed by legal counsel, Ault & Ault (attached).

The new agreement has a five-year term beginning July 1, 2020 and ending June 30, 2025, provisions for SNC use of the property, a termination clause, and terms for the removal of structures.

Scouts Canada volunteers are committed to further use, develop, and improve the site in cooperation with SNC. Scouts Canada will prepare a five-year management plan to support management activities at the site.

SOUTH NATION RIVER CONSERVATION AUTHORITY,

an authority created pursuant to the provisions of the Conservation Authorities Act, R.S.O. 1990, c. C.27,

Hereinafter referred to as the "Authority "
OF THE FIRST PART

- and -

Provincial Council for Ontario; **BOY SCOUTS OF CANADA**, a corporation incorporated under the laws of the Province of Ontario with its head office in Oshawa,

Hereinafter referred to as the "Contractor"
OF THE SECOND PART

RECITALS:

- The Authority is the owner of a property with an area of approximately 54 acres in the Township of North Dundas (described below) which is used primarily for outdoor activities and events, and has been used for several decades by the Contractor;
- ii) The Contractor wishes to continue to use the property for purposes related to the Boy Scouts of Canada, including camps, meetings, outdoor events, etc.

NOW THEREFORE, IN CONSIDERATION of the mutual covenants and agreements contained in this Agreement and for other good and valuable consideration, the receipt and sufficiency of which are expressly acknowledged, the Authority and the Contractor agree as follows:



1. Entire Agreement

The Agreement, together with:

Schedule "A" - Property Description

constitutes the entire agreement between the parties with respect to the subject matter contained in the Agreement and supersedes all prior negotiations, representations, or agreements.

2. Term

The Authority grants to the Contractor the right to occupy and use the properties as described in Schedule "A" attached to this Agreement (and herein called the "Property") from the 1st day of July 2020 to the 30th day of June 2025, unless sooner terminated or extended as herein provided.

3. Payment

The Authority agrees to pay the Contractor for the supervision and management of the Property the sum of \$1.00 per annum to be paid yearly on the 1st day of July.

4. Permission to construct buildings and structures

The Contractor shall consult with the Authority and obtain permission prior to constructing such buildings or structures as it shall deem necessary upon the Property provided however that such buildings or structures erected shall comply with all local by-laws, building codes, and other regulations which shall govern the construction and maintenance of buildings and structures and which shall be in effect from time to time during the term of this Agreement.

The Contractor shall pay all costs associated with obtaining permits, building, and maintaining buildings, and structures.

At the termination of this Agreement for any reason, the Authority shall have the right to require the Contractor to remove any buildings and structures, and the Contractor shall pay any costs associated with the removal and clean up. Costs may include, but are not limited to demolition permits, labour costs, waste removal, and dumping fees.

5. Utilities

The Contractor shall provide and pay for all electric power, telephone services, heating fuels, and all other materials that it may require while managing and using the Property during the term of this Agreement.



6. Permission to alter slope or grade

The Contractor shall not alter the slope or grade of the Property without the written approval of the Authority and the Contractor shall provide to the Authority, at the Authority's request, any plans or other documents which shall relate to any proposed alteration of the slope or grade of the Property. The Contractor covenants and agrees that if any alterations to the slope or grade of the Property shall be made without the written approval of the Authority that the Contractor shall assume full responsibility for any nuisance or damage caused to the surrounding lands and the Authority shall have the right to recover from the Contractor any amounts for which it may be held responsible in law.

7. Clean and maintained premises

The Contractor shall not do or suffer any waste or damage, disfiguration or injury to the Property or fixtures and equipment thereof nor permit or suffer any overloading of the floors thereof and shall not use or permit to be used any part of the Property for any dangerous, noxious, or offensive trade or business or hazardous substances and shall not do anything or permit anything to be done upon or about the Property nor anything to be brought thereon which the Authority may reasonably deem to be a nuisance.

The Contractor shall take every reasonable precaution to protect the Property and buildings from danger of fire, water damage or the elements, and the Contractor shall not allow any ashes, refuse, garbage or other loose, objectionable material to accumulate in, or about the Property or the buildings and will at all times keep them in a clean and wholesome condition. The Contractor shall maintain and keep the Property, buildings, structures, and fixtures in such good order and condition as they would be kept by a reasonably careful landowner and make all needed repairs and replacements as shall be reasonably necessary.

8. Chattels and fixtures

The Contractor may remove its fixtures at the end of the term of this Agreement and the Contractor may remove from the Property during the term of this Agreement any chattels, fixtures, or effects which are the property of the Contractor without the written consent of the Authority.

All installations, alterations, additions, partitions, and fixtures installed or erected by the Contractor during the term of this Agreement shall become the property of the Contractor upon the termination of this Agreement.

Notwithstanding anything contained in this Agreement, the Authority shall be under no obligation to repair or maintain any installations, alterations, additions, partitions, and fixtures or anything in the nature of general improvements made or installed by or for the benefit of the Contractor.

At the termination of this Agreement for any reason, the Authority shall have the right to



require the Contractor to remove any chattels and fixtures, and the Contractor shall pay any costs associated with the removal and clean up.

9. Licenses and permits

It is the responsibility of the Contractor to obtain, obey, and pay for all necessary permits and licenses required by statute or by any by-law, order, or regulation having the force of law. The Contractor shall provide copies of such permits and licenses to the Authority upon reasonable request for same.

10. Scheduling

The Authority will be able to schedule Authority events on the property, through the Contractor, for times that the property is not previously scheduled for Contractor events. There shall be no cost for these events.

11. Ownership

This Agreement is not intended to and shall not be construed to vest in the Contractor any title or property rights in the real estate, fixtures, or personal property belonging to the Authority not located or which may be located thereafter in or around the Property occupied by the Contractor or anyone employed by the Contractor under this Agreement.

12. Insurance

The Contractor represents, warrants, and covenants that it has and shall maintain, at its own cost and expense, all the necessary and appropriate insurance that a prudent person carrying out a similar project would maintain.

The Contractor shall maintain comprehensive general liability insurance on an occurrence basis for third party bodily injury, personal injury, and property damage to an inclusive limit of not less than five million dollars (\$5,000,000) per occurrence.

The insurance policy shall:

- (a) name the Authority as additional insureds with respect to liability arising in the course of performance of the Contractor's obligations under, or otherwise in connection with, the Agreement;
- (b) contain a cross-liability clause; and
- (c) require 30-day written notice of alteration or cancellation.

The Contractor shall provide SNC with certificates of insurance that confirm the insurance coverage required by this Section.

The Contractor shall pay for all premiums and expenses incurred for the insurance.



The Contractor shall be financially responsible for paying any amount(s) up to and including the deductible under their policies should any claim(s) arise.

In the event that the Contractor fails to insure as herein required or fails to promptly furnish to the Authority satisfactory evidence of such insurance or of the renewal thereof prior to its expiration, the Authority may from time to time effect such insurance for the benefit of the Contractor or the Authority or both of them for a period not exceeding one (1) year and any premium paid by the Authority shall be recoverable by the Authority as if the same were a debt owing by the Contractor to the Authority.

13. Indemnity

The Authority shall not in any event whatsoever be liable or responsible in any way for any personal injury or death that may be suffered or sustained by the Contractor or any employee of the Contractor or any other person who may be upon the Property or any common areas or for any loss or damage or injury to any property belonging to the Contractor or its employees or to any other person while such property is on the Property and in particular, but without limiting the generality of the foregoing, the Authority shall not be liable for any damage to any such property caused by steam, water, rain or snow which may leak into, issue or flow from any part of the building or any adjoining premises or areas or from the water, steam, sprinkler or drainage pipes or plumbing works of the same or from any other place or quarter or any damage caused by or attributable to the condition or arrangement of any electrical or other wiring or for any damage caused by anything done or admitted to be done by the Contractor.

The Contractor shall indemnify and save harmless the Authority of and from all liabilities, fines, suits, claims, demands, and actions of any kind or nature to which the Authority shall or may become liable for or suffer by reason of any breach, violation or nonperformance by the Contractor of any covenant, term or provisions thereof or by reason of any injury or death resulting from, occasion to or suffered by any person or persons or any property by reason of any act, neglect or default on the part of the Contractor or any of its agents and employees; such indemnification in respect of any such breach, violation or nonperformance, damage to property, injury, or death occurring during the term of this Agreement shall survive any termination of this Agreement, anything in this Agreement to the contrary notwithstanding.

The Contractor shall indemnify and hold the Authority harmless from and against any liability, claim, damages, or expenses (including legal expenses) due to or arising from any claim made against the Property or the building for all liens related to all work done by or on behalf of the Contractor and all work which the Contractor is obliged to do and any such liability, claims, damages or expenses incurred by the Authority as a result of any such actions by the Contractor shall be repaid forthwith upon demand; and the Contractor shall cause all registrations of claims for liens and/or certificates of action under the *Construction Lien Act* and relating to any such work done by or on behalf of the Contractor, and all work which the Contractor is obliged to do, to be discharge or vacated as the case may be within fifteen (15) days of such registration or within five (5) days after



notice from the Authority, failing which the Authority, in addition to any other rights or remedies it may have hereunder, may, but shall not be obligated to, discharge such liens and/or certificates by payment to the Claimant, payment into the Court, or otherwise; any such payments and the Authority's legal costs (on a solicitor and his client basis) and other costs of obtaining and registering such discharges shall be prepaid by the Contractor to the Authority forthwith after notice thereof, and shall be recoverable as if the same were a debt arising under the terms and conditions of this Agreement.

14. Notice

All notices or other documents required or which may be given under this Agreement shall be in writing, duly signed by the party giving such notice and transmitted by registered or certified mail, or fax addressed as follows:

15. Termination

The Authority and the Contractor agree that this Agreement may be terminated by either party upon providing the other with written notice of intention to terminate not less than ninety (90) days in advance of the date of termination and no penalties shall be imposed as a result of the proper exercise of the said right of termination.



If the Contractor breaches a term of this Agreement, the Authority may provide notice of the breach to the Contractor in writing, including outlining the necessary steps for the Contractor to remedy the breach. If the Contractor fails to remedy the breach within seven (7) business days, the Authority shall have the right to immediately terminate the Agreement on the first business day following the seven-day notice period.

16. Waiver

No waiver of any of the agreements or obligations herein contained by either of the parties hereto shall be construed as a waiver of any succeeding breach thereof or of any other covenant, agreement or obligation contained in this Agreement, and no delay or omission on the part of either party hereto to exercise any right acquired through the default of the other shall be construed as a waiver of or shall impair such right.

17. Severability of Clauses

The invalidity or unenforceability of any term of this Agreement does not affect the validity or enforceability of any other term. Any invalid term shall be treated as severed from the remaining terms.

18. Assignment

This Agreement shall not be assigned or subcontracted without the consent, in writing, of the Authority.

This Agreement shall be binding upon both the Contractor, its successors, heirs, and assigns and upon the Authority, its successors, heirs, and assigns.

19. Amending the Agreement

The Agreement may only be amended by a written agreement duly executed by the parties.

20. Governing Law

This Agreement shall be governed by the laws of the Province of Ontario.

The Board of Directors approves the adoption of a Video Surveillance Policy, with final changes as required by legal counsel.

DISCUSSION:

Two locations would benefit from the installation of video cameras:

- 1. SNC Administration Building external entry doors
- 2. Chesterville Dam control building, main gate, and water level

The benefits include:

- Improved safety and security of staff and property
- Saved staff trips important information and events can be verified remotely
- Opportunity for public education live feeds of water levels and ice.

Our human resources lawyer advises that SNC adopt a Video Surveillance Policy to govern the installation of the cameras and ensure compliance with privacy legislation.

POLICY:

- 1. The South Nation Conservation Authority (SNC) may use video surveillance systems around its buildings and/or exterior properties to help to provide a safe and secure environment for its workers and users of its premises, to assist in providing efficient monitoring of water levels and blockages on SNC lands, to provide education content to further its mandate, and to protect SNC assets.
- 2. Video surveillance systems will be used according to the following criteria:
 - a) to ensure compliance with the Municipal Freedom of Information and Protection of Privacy Act (MFIPPA) that governs SNC's operations;
 - b) to provide general surveillance without limiting general public activities;
 - c) to act as a deterrent against vandalism to buildings and property;
 - d) to maintain a balance between the advantages of video surveillance for the public and the specific right to protect privacy;
 - e) to regularly review and evaluate the video surveillance program in order to ascertain if continued use is justified in accordance with the requirements for collecting personal information.
- 3. Video surveillance systems are defined as a video, physical or other mechanical, electronic or digital surveillance system or device that enables continuous or periodic video recording, observing or monitoring of individuals in SNC's buildings and on public property operated by SNC.

ADMINISTRATIVE PROCEDURES:

Authority and responsibility

- 1. The installation, maintenance and use of digital surveillance equipment will be in accordance with MFIPPA.
- 2. The Team Lead Corporate Services or their designate is responsible for overseeing the SNC video surveillance program.
- 3. The Team Lead Corporate Services is responsible for ensuring that the day-to-day operation of, access to, and use of video surveillance meets the requirements of the SNC's policy and ensures compliance with respect to collection, use, disclosure, access, retention and disposal of records containing personal information collected through video surveillance. Preliminary access to recordings is limited to the authorized personnel noted above.
- 4. Individuals who use, review or make decisions with respect to the video surveillance program must be advised of, and agree to uphold, their responsibilities under MFIPPA as a condition of their use/participation.



Notice of surveillance

- 5. Signs/notices will be posted at main entrances to the areas under surveillance to indicate the presence of video surveillance systems. Such signs will accord with the requirements of MFIPPA.
- 6. At present, the areas under surveillance include:
 - a) The three external entry doors to the SNC Administration Office in Finch
 - b) The control building, main gate, and water at the Chesterville Dam, Chesterville.

These areas may be amended, or others added, provided that the appropriate notice at the locations of collection is provided.

Video surveillance installation and operations

- 7. No video surveillance shall be installed without an assessment to determine if surveillance in the new location is justified, and what steps can be taken to reduce any deleterious effects of the surveillance.
- 8. Video surveillance will not be used in areas where individuals have a reasonable expectation of privacy such as washrooms or change rooms. External video cameras will not be used to view/capture images of non-SNC properties.
- 9. Prior to installing additional video surveillance, additional approval must be sought from the General Manager/Secretary-Treasurer.
- 10. The images collected by the video surveillance will be kept in a locked, secure location. Access to these records shall only be for the purposes identified earlier in the policies. Only designated individuals shall have access to this location and the recorded material. In the event that video surveillance is viewed or disclosed (as permitted by law), SNC shall keep records confirming the access or disclosure in order to comply with its obligations under MFIPPA.
- 11. Any cameras which are used to create a live feed of SNC property for public education or operational assistance will be positioned in such a way as to limit/omit the capturing of any images of individuals using SNC property. For clarity, the live feed cameras will only be directed at the main gate and water level at Chesterville Dam, where members of the public and staff should not be present.
- 12. In circumstances where cameras are used to broadcast a live feed as a means of public education or operational assistance (such as monitoring for ice dams etc), the video feed shall only be reviewed to the extent necessary to carry out these functions.



13. Periodic maintenance of video surveillance systems will be performed by SNC staff based on a schedule that will ensure efficient operation of the system.

Retention of surveillance recordings

- 14. Video surveillance recording may take place 7 days per week, 24 hours a day, as limited by the digital recording device capacity. Recordings are not monitored in real time and will be reviewed only where there is an operational need to do so.
- 15. The retention period for surveillance video will be limited by the storage capacity of the recording device. The raw feed will be recorded over or destroyed within 30 days unless required as part of an ongoing investigation.
- 16. If video surveillance images are used as part of an investigation, they must be kept for at least one year. After the year has elapsed, these records will be destroyed unless there are other legal requirements that they continue to be kept for a longer period of time.

Disclosure of the video surveillance

17. Images captured by the video surveillance system shall only be disclosed as permitted by MFIPPA. In cases of requests for disclosure, SNC will satisfy itself that the disclosure is permitted by law before releasing any information.

Regular review of this policy

18. On a periodic basis, the video surveillance system will be reviewed in order to determine if installation is still justified, and that the capture of personal information is limited to that which is necessary to further the aims of the policy, as previously identified.

Subject: Request for Approval: Conservation Area Project Expenditures

RECOMMENDATION:

The Board of Directors approve Conservation Area project expenditures at the J. Henry Tweed, W.E. Burton, and Augusta Conservation Areas for a total cost of approximately \$45,000, plus HST.

DISCUSSION:

Annual maintenance, property improvements and restoration projects are planned at SNC Conservation Areas every year, and professional services are needed to support various work activities, included in the 2020 SNC Budget.

The following 3 Conservation Area projects require services and expenses over \$10,000 to complete scheduled work, which require Board Approval.

J. Henry Tweed Conservation Area

Ontario Land Surveyor services are required to complete the Shoreline Restoration Project. Work is 100% funded by Ontario Power Generation and included in budget. Quotes are obtained and work will be awarded to the lowest bid, approximately \$15,000.

W.E. Burton Conservation Area

Tree management services are required to support the removal of 150 dead trees impacting public safety and the ecological integrity of the forest. Work is scheduled alongside restoration activities being completed by SNC, due to destruction of part of the trail system. Work for hazard tree removal is included in budget. Quotes will be obtained, and work will be awarded to the lowest bid, approximately \$15,000.

Future Conservation Area in Augusta

SNC requires the purchase of materials to support the creation of a parking lot, trail, and river access. Work is 100% funded by the Government of Canada through the Canadian Experiences Fund and is included in budget. In-kind support will be provided by the Township of Augusta on work activities, quotes are obtained for aggregate and material purchases and work will be awarded to the lowest bids, approximately \$15,000.

J. Henry Tweed Conservation Area: Expenses for the Ontario Power Generation Biodiversity Fund are included in the 2020 SNC Budget under Stewardship: Federal and Provincial Grant Programs, pages 28 and 29.

FURTHER THAT: The Board of Directors approve signing a Transfer Payment Agreement with the Ministry of Natural Resources and Forestry for the 2020-2021 Water and Erosion Control Infrastructure funding.

DISCUSSION:

The Board of Directors approved the projects submission to the Ministry of Natural Resources and Forestry, (MNRF) 2020-2021 Water and Erosion Control Infrastructure, (WECI) program at the February 2020 meeting (Resolution #BD-033/20).

At the beginning of June, SNC was informed that the Mitigation of Flood Risk at the Chesterville Dam – Phase 2 was approved. This project is a continuation of the work completed in 2019. This phase of the project includes retaining qualified services to install a new furnace and replace corroded electrical connections inside the automatic gate and upgrades to the electric system at approximately \$80,000.

Signing a Transfer Payment Agreement with MNRF is required to secure the funding (\$40,000).

FINANCIAL IMPLICATIONS/ADHERENCE TO SNC POLICY:

<u>Compliance with Budget</u>: Mitigation Flood Risk at the Chesterville Dam – Phase 2: SNC's matching contribution to be taken from reserves.

<u>SNC Policy Adherence</u>: Project expenditures will adhere to SNC's Purchasing Policy, including seeking three quotes and required authorizations according to purchasing limits.

RECOMMENDATION:

The SNC Board of Directors approve submitting retroactive proposals to the Eastern Ontario Water Resources Program for the Water Budget Update – Phase 1 and City of Ottawa Weather Station projects; and

FURTHER THAT: The SNC Board of Directors approve expenditures to complete the Water Budget Update – Phase 1 at approximately \$35,000, plus HST; and

FURTHER THAT: The SNC Board of Directors approve expenditures to complete the City of Ottawa Weather Station projects at approximately \$22,000, plus HST; and

FURTHER THAT: The SNC Board of Directors approve sole sourcing the purchase and installation of equipment for the City of Ottawa Weather Station to Forest Technology Services (FTS) at approximately \$22,000, plus HST, to ensure compatibility with existing products.

DISCUSSION:

The Eastern Ontario Water Resources Program (EOWRP) supports 35 recommendations to protect surface and ground water resources in Eastern Ontario. The City of Ottawa has provided funding for not-for-profit organizations to complete projects which address one or more of the recommendations.

1. Project: Water Budget Update – Phase 1

EOWRP Request: \$10,000

Purpose: SNC has budgeted \$35,000 to complete the Phase 1 – Water Budget Update. After proposal submission, SNC was successful in receiving \$9,500 from EOWRP to complete the project. The project includes the water budget update for the South Nation River watershed using SNC's state-of-the-art HydroGeosphere model. An updated water budget is essential for the South Nation River watershed to effectively evaluate how future climate changes may impact water resources. SNC will research future climate, land use and water demand scenarios, supported through climate science and Municipal outreach activities.



2. Project: City of Ottawa Weather Station Project

EOWRP Request: \$10,000

SNC submitted a proposal to the EOWRP and was successful in receiving \$9,500 for the installation of a continuous, real-time data collection platform and weather station within the City of Ottawa. This station improves the Flood Forecasting and Warning Program by filling in known data gaps for precipitation. Timely and reliable climate information on extreme precipitation events is essential to reducing the impacts of floods and droughts in Ottawa and Eastern Ontario.

Staff propose to purchase the weather station and telemetry equipment from Forest Technology Services (FTS). There is a requirement to sole source from FTS to ensure equipment compatibility with the existing Monitoring Network.

RECOMMENDATION:

The Board of Directors approve the 2020/2021 Tree Planting Fee Schedule; and

FURTHER THAT: The Board of Directors approve the purchase of tree seedlings at approximately \$135,000, plus HST, subject to approval of the 2021 Budget; and

FURTHER THAT: The Board of Directors approve the sole source purchase of 2021 tree seedlings from Ferguson Tree Nursery, or from other Forest Ontario approved nurseries if stock is not available locally at Ferguson Tree Nursery.

DISCUSSION:

Preparations for 2021 spring tree planting begins in 2020 with site visits to prospective planting sites, site preparation, and ordering of tree seedlings. Board of Directors approval is required to set the 2020/2021 tree planting fee schedule and purchase tree seedlings.

1. 2020/2021 Tree Planting Fee Schedule Forests Ontario: 50 Million Tree Program

South Nation Conservation (SNC) offers tree seedlings and a planting service to eligible property owners under the Forests Ontario 50 Million Tree Program (50 MTP). The 50 MTP provides a subsidy per seedling with the remaining costs paid for by the landowner, as per the annually approved SNC Tree Planting Fee Schedule.

The landowner fee per tree seedlings has remained status quo for several years, however, costs for site preparation, tree planting, and tending have increased in 2020. Also, previous fee schedules did not list the costs for site preparation, planting, or tending services which are invoiced to the landowner.

Staff recommend adjusting the SNC 2020/2021 Tree Planting Fee Schedule to reflect all fees and increased program costs. Site preparation, planting, and tending costs in the proposed fee schedule (see attached) reflect the contracted services cost; cost per seedlings have been increased by \$0.05/seedling from previous fee. The proposed fee schedule would be in effect from June 2020 to May 2021.



SNC Over the Counter Sales

Property owners, with planting sites that do not meet the minimum size requirements for the 50 MTP, can also purchase tree seedlings through the SNC Over the Counter program. Over the Counter prices reflect the nursery stock cost plus 15% for shipping and handling, this is status quo to the spring 2020 fees.

2. Purchase of Tree Seedlings

The number of tree seedlings to be planted in 2021 is established through site visits that occur from July to October of 2020. SNC must reserve its expected seedling requirements this fall for spring delivery. Based on requests for site visits, staff expect that 2021 nursery stock requirements will be slightly higher than in 2020, the cost of seedlings is estimated at \$135,000, plus HST; purchase is subject to the approval of the 2021 budget.

The Ferguson Tree Nursery in North Grenville is the only eastern Ontario nursery, approved by Forests Ontario for supplying stock to the 50 MTP, with the capacity to produce a large number of native seedlings corresponding to this seed zone (seed zone 36). For this reason, staff recommend that SNC purchase its tree seedlings from the Ferguson Tree Nursery.

There are three other large nurseries, located in southern Ontario and western Quebec, approved by Forests Ontario; if species are not available from Ferguson Tree Nursery, staff will source stock from these approved nurseries who also grow native species from seed zone 36.

FINANCIAL IMPLICATIONS/ADHERENCE TO SNC POLICY:

Compliance with Budget:

The tree planting program is included in the 2020 Budget under Resource Management, Partner Programs, Forests, pages 16-17.

SNC Policy Adherence:

As per the SNC Purchasing Policy, section (E) Non-Competitive Purchase, the Board of Directors must approve any non-competitive purchasing over \$10,000. The non-competitive purchase of tree seedlings is sought due to a limited number of seedling nurseries, approved by Forests Ontario, that can guarantee seed zone-sourced stock, within reasonable shipping distance.

Subject: Request for Approval: Hazard Land Acquisition Reserve

RECOMMENDATION:

The Board of Directors approve allocating \$25,000 from the 2020 Budget to the Hazard Land Acquisition Reserve.

DISCUSSION:

The 2020 Budget includes an allocation to create a Hazard Land Acquisition Reserve. The purpose of this reserve fund is to acquire hazard lands when there is a: willing vendor; of an inhabited dwelling; in an area where there is a known risk to life because of underlying hazard lands.

Under the Conservation Authorities Act, hazard lands are defined as "land that could be unsafe for development because of naturally-occurring processes associated with flooding, erosion, dynamic beaches or unstable soil or bedrock"; for example, the lands within the Casselman-Lemieux Potential Retrogressive Landslide Area.

The Casselman to Lemieux Potential Retrogressive Landslide Area (the "PRLA") is a 20 kilometer stretch of the South Nation River between Casselman and the former Hamlet of Lemieux susceptible to large-scale retrogressive landslides. There are currently 27 residences, [approximately 200 parcels, and several roads] in the Nation Municipality within the PRLA.

The PRLA has been studied extensively over the past three decades in response to several large-scale landslides, occurring most recently in 1971 and 1993. The geotechnical studies and historical data revealed that a major retrogressive landslide could occur at any time within the PRLA – endangering lives and resulting in the loss of buildings, infrastructure, and land.

Staff seek approval to establish the Hazard Land Acquisition Reserve and transfer the 2020 Budget allocation of \$25,000 to this reserve.

The reserve is intended to leverage other sources of funding to complete purchases that reduce risk to life. In the 1990s, all levels of government supported the acquisition of 28 residences from willing sellers at a cost of \$2.2 million dollars.



All levels of government have and will continue to be approached to support this issue: this commitment, while inadequate to fund extensive purchases, will be the first to proactively establish commitment to reducing the number of homes remaining in the potential retrogressive landslide area.

Subject: Natural Infrastructure is an Integral Part of Green Recovery

Dear Prime Minister:

Natural infrastructure¹ projects create good jobs, support local supply chains, and provide a variety of environmental, social, and health benefits. Natural infrastructure can also reduce capital and operating costs for municipalities and Indigenous communities to provide essential services. Support for natural infrastructure solutions as part of a post-COVID green recovery stimulus would help to realize all of these benefits, as well as meeting specific mandates across several federal departments, including Infrastructure, Environment and Climate Change, Natural Resources, Agriculture and Agri-Food, and Public Safety.² The case is strong for the value these solutions hold both in advancing climate resilience, disaster risk reduction, enhanced biodiversity and supporting economic recovery.

This letter provides detailed recommendations for short- and medium-term investment in natural infrastructure as an integral part of Canada's economic recovery from the COVID crisis and its long-term resilience to climate change. Financial support for smaller, job-rich natural infrastructure projects across the country will create benefits that go beyond any one project. In addition to their positive economic impact, natural infrastructure projects can be implemented much more quickly than large-scale grey infrastructure projects to provide climate resilience (e.g., inland flood protection, coastal protection, and mitigation of urban heat island effects) while offering additional benefits (as compared to their grey alternatives), such as improved water quality, supporting biodiversity, and (perhaps most importantly in these challenging times) offering mental health benefits. In short, investment in natural infrastructure will allow us to build back better. In order to realize all of these benefits, our specific recommendations³ are:

- 1. Get money moving: Expedite funding to: 1) projects that are "shovel-ready" and "shovel-worthy"; and 2) to readiness-assessments and other early stage support to create an ongoing pipeline of fundable projects. Benefits include immediate jobs and support for local supply chains. Indigenous peoples must be engaged in all projects impacting their traditional territories, consistent with the principles of free, prior and informed consent as set out in the United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP).
- **2. Keep money moving:** Modify existing programs, such as the Disaster Mitigation and Adaptation Fund (DMAF) and the Investing in Canada Infrastructure Program (ICIP) to address current barriers for natural infrastructure projects. Concurrently, continue to fund ongoing monitoring, measurement and evaluation of initial "shovel-ready" projects.
- 3. Sustained support: Enable integrated policy, programs and legislation over the longer-term, including the establishment of a dedicated natural infrastructure fund.

The case for the benefits of natural infrastructure is becoming increasingly clear. A recent report released by the Green Infrastructure Ontario Coalition highlights the economic impact of natural infrastructure solutions in Ontario. It calculated that the sector contributed \$8.33 billion in GDP and 122,000 jobs in the province in 2018.⁴ Comparing that to Ontario's total sector jobs, that aligns it just behind the real estate sector (which employed an estimated 166,000). Previous reports, such as from the Intact Centre on Climate Adaptation, the International Institute for Sustainable Development⁵ and the Insurance Bureau of Canada⁶ have highlighted the high return on investment in natural infrastructure projects across Canada, for climate resilience and disaster risk reduction, in particular, to flooding, which has emerged as the costliest and most pervasive natural disaster nationally in the past decade. In addition, a 2019 Environment and Climate Change Canada commissioned report found that for comparable infrastructure outcomes, nature-based infrastructure solutions provide significant additional benefits and more often at much lower cost as compared to grey alternatives.⁷

Beyond the size of the sector, natural infrastructure efforts require the collaboration of a diversity of partners, including: municipal planners, landscape architects, engineers, biologists, farmers, non-governmental organizations and academics (to name just a few). This diversity of partners also reflects the diversity of employment opportunities from design, to project management, to site construction, to horticulture, and long-term maintenance, evaluation and monitoring.

There are thousands of "shovel-ready" and "shovel-worthy" projects across the country and within Indigenous communities. Research by a number of groups, including a pending analysis by the Our Living Waters Network, adds fodder to the mounting evidence on the opportunities, citing projects across the country, communities, and nations. The more than 250 curated projects cover a diverse range of works, including: creek restorations; rain gardens; household green infrastructure tools; efforts to fill science and data gaps; flood management; wetland restoration in both urban and agricultural communities; tree plantings; and bioswales. In addition, organizations such as the Municipal Natural Assets Initiative have proven methodologies and tools to help local governments assess, plan and implement natural asset management projects that deliver core local government services. Deploying these methods as part of a larger investment in natural infrastructure would help local governments plan and design effective projects for funding under existing programs, such as DMAF and ICIP.

In addition, organizations such as the Municipal Natural Assets Initiative have proven methodologies and tools to help local governments assess, plan and implement natural asset management projects that deliver core local government services. Deploying these methods as part of a larger investment in natural infrastructure would help local governments plan and design effective projects for funding under existing programs such as the Disaster Mitigation and Adaptation Fund (DMAF) and the Investing in Canada Infrastructure Program (ICIP).

There are also numerous projects that have been cancelled or put on hold due to the economic downturn, which could quickly and easily be revitalized with renewed funding. In many cases plans have already been developed, but projects cannot move forward due to lack of money to hire staff or purchase supplies.

Our consortium will continue our efforts to develop a long-term roadmap to ensure that the natural infrastructure movement is normalized municipally, provincially and federally. In looking to solve our infrastructure challenges across the country, natural infrastructure solutions will be a top priority.

There is no silver lining in the devastation that COVID-19 has brought to our communities, our households, our country. We can, however, make sure that the responsive investments truly advance more resilient, healthy and sustainable communities into the future. We welcome and request the opportunity to explore this conversation with you all in more detail.

Appendix 1 - Policy and Program Recommendations to Support Natural Infrastructure Investment

Get Money Moving

The following actions could be taken to support quick movement of money and resources in support of natural infrastructure.

- a. Expand funding and support for municipality and community "readiness" assessments and preparation for future work, including:
 - i. Greenhouse Gas (GHG) assessments (ECCC / INFC);
 - ii. Climate risk analysis and adaptation planning (ECCC);
 - iii. Species at Risk (SAR) assessments (ECCC);
 - iv. Afforestation and deforestation reduction (ECCC / NRCAN);
 - v. Natural asset and regulatory barrier assessments (INFC / ECCC) to develop and support the application of tools to quantify natural infrastructure benefits (GHG, water quality, biodiversity, costs etc.).
- b. Make immediate funding available to advance natural infrastructure projects via a "start up" Natural Infrastructure Fund (INFC) and monitoring program (INFC and ECCC). This would include:
 - i. Support for pilot initiatives;
 - ii. Establishing standardized monitoring and evaluation;
 - iii. Strengthening local supply chain for native plants and saplings;
 - iv. Support across sectors including small businesses, municipalities, science and academic institutions, and non-governmental organizations.



via medium term investments and adjustments in existing programs.

- a. Revise infrastructure funding program requirements, including DMAF and ICIP to facilitate broader NI investment (INFC w/ ECCC). Specifically:
 - i. Remove or revise capital asset and expenditure requirements to better incent natural infrastructure initiatives;
 - Enable strategies for getting smaller, more numerous, funding dockets out the door (using intermediaries for example)
 - iii. Reducing bottle-necking by easing multiple jurisdiction requirements.
- b. Fund science gaps as needed to support the development of tools, procedures and openaccess data hubs to support publicly accessible data analysis (ECCC and NRCan);
- c. Develop an ecosystem GHG emissions and biodiversity screen for infrastructure investment/criteria to assess the GHG emissions from downstream impacts of destroying natural assets for climate resilience and disaster risk reduction.



via policy evolution and programs for mainstreaming.

- a. Develop simplified GHG offset protocol or other incentive programs for "natural asset" landowners (ECCC);
- b. Support the development of clear metrics for natural infrastructure outcomes, such as lower costs related to disasters, and cleaner water;
- c. Develop public-private finance mechanisms to advance natural infrastructure solutions;
- d. Support the development of consistent and clear regulations and policy tools in provinces and municipalities that prioritize natural infrastructure options for infrastructure needs, (for example, to allow natural assets in public service accounting frameworks, more stringent requirements to manage stormwater on site, etc.);
- e. Establish an inter-departmental working group alongside an expert advisory committee to streamline ministry programs, identify government-wide targets, monitoring and outcome measure for natural infrastructure projects across ministries (INFC, ECCC, AAFC, NRCAN, PSC, DFO);
- f. Support education and professional development of the sector.

Re: Conservation Authorities: Next Steps

Dear Minister Yurek,

On behalf of our member conservation authorities (CAs), I am writing to lend our support for AMO's May 19th letter to you in which they express concerns about the next steps to be taken with Conservation Authorities.

It is understood and supported that managing COVID-19 related activities is everyone's immediate priority, and, it is also agreed that moving forward in the transformation of the Conservation Authority and municipal relationship needs to occur in a manageable way.

Conservation Ontario has been surveying the CAs on disruptions and impacts to their delivery of programs and services, as well as, considering how we can support all levels of government in economic stimulus and job recovery during and post-COVID-19. While the impact is variable across the CA community, all have experienced significant revenue reductions, which in some cases has resulted in layoffs of permanent staff and seasonal staff not being hired (including some who support the flood management program), cancellation of programs (many of which are revenue-generating), and, closure of conservation areas. All these impacts have certainly had broader impacts to the local economies across the Province but can be resolved with time, collaboration and support tools. CAs are very keen to support all levels of government in economic recovery and job creation with shovel ready projects.

Conservation Authorities share AMO's concerns with regard to the impacts of COVID-19 on municipal (and CA) workloads. In particular, we have heard concerns with regard to the potential additional complexity to the CA/municipal budgeting process if there are no clear communication protocols and tools available to facilitate changes that CAs and municipalities will need to implement. Some conservation authorities and municipalities have even gone so far as to suggest that this is not the right time to be creating any new pressures on CA/Municipal budget

processes, particularly in the midst of dealing with impacts from COVID-19 and the need for economic recovery.

The above is one example of challenges that might be experienced in implementing amendments made under the *Conservation Authorities Act*. As you and your staff move forward with finalizing your analysis of feedback from consultations to date, we ask that the Ministry meet with Conservation Ontario staff and AMO staff jointly to discuss outcomes and approaches to move forward efficiently.

Finally, Conservation Ontario also supports the Province moving forward as expeditiously as possible to finalize the Section 28 regulation consultations being led by the Ministry of Natural Resources and Forestry [i.e. ERO#013-4992: "Focusing conservation authority development permits on the protection of people and property"] as well as updates to the supporting technical guides. Progress in this important business area would be consistent with concerns raised in the MECP Stakeholder Engagement sessions, and with priorities identified in the Made-in-Ontario Environment Plan, and, Ontario's Flooding Strategy. The Section 28 Regulations are a critical component of Ontario's approach to reducing risks posed by flooding and other natural hazards and strengthening Ontario's resiliency to extreme weather events.

Thank you for your consideration in support of all our efforts to continue to serve Ontarians during these challenging times while moving forward on your vision for Conservation Authorities in Ontario. We look forward to continuing to work together in this regard and CO staff are available at your convenience.
