RECOMMENDATION:

That the Communications Committee receive and file the update on 2021 Virtual Outreach Initiatives – Maple Education Program.

DISCUSSION:

In March 2021, the Communications Committee approved a revised Maple Education Program due to the ongoing COVID-19 Pandemic and school restrictions in place that did not allow students to visit the popular Conservation Area to learn about maple syrup education and demonstration (CMN-008/21).

As part of the revised program, South Nation Conservation (SNC) committed to:

- Postponing on-site Maple Education Program tours.
- Creating a maple syrup demonstration video.
- Hosting Maple Weekend days at the Oschmann Forest.
- Sharing an online Maple Education social media campaign.

SNC was able to host one Maple Weekend event that drew in approximately 500 visitors to the Oschmann Forest Conservation Area to enjoy a self-guided interpretive forest tour, along with complimentary maple treats provided at a campfire on-site. A second event was cancelled due to the announcement of a provincial Stay-at-Home Order.

Due to the field trip restrictions in place, the Ottawa Catholic School Board partnered with SNC to cost-share a project to complete two video products for Kindergarten to Grade 3 and Grade 3 to Grade 6 students. \$4,520 was received from the Ottawa Catholic Board.

The Maple Education Videos were shared with over 30,000 elementary school students at 102 schools within the Ottawa Catholic Board. Videos were also shared online and were provided to some schools within the Ottawa-Carleton Board, Upper Canada Board and the Catholic District School Board of Eastern Ontario.

The videos take students on a "sweet" virtual tour of the Oschmann Forest and includes teachable moments from SNC's Maple Education Program which aligns with Ontario's education curriculum objectives.

An online social media campaign complemented the virtual programming and helped to direct the public to local maple syrup producer facilities that were safely open to accommodate visitors.

DISCUSSION:

South Nation Conservation (SNC) partnered with the Ministry of the Environment, Conservation and Parks to support the development of virtual Great Lakes field trips for students to experience their local environment during the COVID-19 Pandemic and use local watershed to inform key science and geography curriculum objectives (CMN-005/21).

Project specific deliverables included writing a script, selecting visual media, recording and editing video content, creating and piloting the virtual field trip, and releasing and promoting the final product to school boards and partner organizations.

Existing partnerships with school boards were leveraged to support implementation of this program and review of the educational content.

Memorandums were distributed to all School Boards in Eastern Ontario and information packages were requested from 20 School Boards to distribute to their teachers. Advertising also occurred on social media.

The remaining project deliverable is to prepare the online presentation in French. The product translation has begun and SNC aims to make the Virtual Field Trip available in French later in 2021.

Field trip products will support SNC's suite of environmental outreach programming and include indigenous knowledge sharing.

RECOMMENDATION:

That the Communications Committee receive and file the update on the 2021 Municipal Tree Giveaway activities.

Further that the Committee recommend that the SNC Board of Directors continue to provide annual support for community free tree campaigns.

DISCUSSION:

South Nation Conservation's (SNC) Municipal Tree Giveaway activities began in 2019, as a recommendation from SNC's Forest Conservation Initiative (BD-123/18).

The Community Free Tree campaigns aim to support the following objectives:

- Promote forest conservation;
- Share information on the status of forest cover in Eastern Ontario;
- Identify municipal support for forest conservation and tree planting;
- Connect with additional people to share SNC Tree Planting Program info;
- Enlist future tree planting partners through SNC programs;
- Engage people in the stewardship of their local environment;
- Provide families eco-friendly activities through the COVID-19 Pandemic:
- Help spruce up, green, and naturalize watershed communities.

The 2021 SNC Free Tree Pick Ups took place throughout the month of May with 18 pick up locations within SNC's partner municipalities.

This year's activities were branded as "Free Tree Curbside Pick Ups" and were delivered in a revised format through the ongoing COVID-19 Pandemic.

An online reservation portal was launched to provide people with an opportunity to request free tree seedlings. Information including contact information, addresses, municipality, and preferred tree species and preferred pick-up times were collected.

Over three thousand requests were received and SNC worked through the month of May to schedule curbside pick-up activities daily. Tree seedlings were secured on a first-come-first-served basis.

Municipalities helped co-host curbside pick ups where residents were given a specific time to pick up their bundle of 5 tree seedlings. Safety plans were established for each pick-up site and were reviewed by the local health unit.



Over 10,000 free tree seedlings were handed out, with 80-200 households in each municipality receiving bundles of 5 seedlings, depending on the amount of funding secured.

Fundraised revenue and partner funding was secured to support this program in 2021:

- \$6,500 from SNC's Art for Trees Online Silent Auction (CMN-004/21)
- \$2,500 from Forest Ontario (to reduce the tree seedling purchase price by \$0.25/tree)
- \$5,000 from 8 partner municipalities (to support the distribution of additional trees)
- \$750 from the Raisin Region Conservation Authority (for the 3 shared municipalities)

To thank frontline workers, SNC also donated 1,100 Norway and Blue Spruce seedlings to the Winchester District Memorial Hospital, the Glengarry District Memorial Hospital, and the Cornwall Community Hospital during National Nurses' Week.

SNC plans to continue with this program and campaign into the future.

RECOMMENDATION:

The Communications Committee recommends the Board of Directors approval of Community Environmental Grants in the amount of \$300 each to:

SD&G Library, Butterflyway Project, Chesterville Kayak Club, Russell Groves Community Association, the Chesterville District Agricultural Society, Roxborough Agricultural Society and St. Anne's Catholic School.

DISCUSSION:

In March 2021, the Communications Committee approved amendments to South Nation Conservation's (SNC) Community Environmental Grants Program to allow applications for tree and shrub planting and community garden development in response COVID-19 related event cancellations (CMN-036/20).

The Committee also directed staff to engage with community groups and past project partners to support new funding applications (CMN-036/20).

The following applications for the amended Community Environmental Grants Program have been received:

SD&G Library:

The SD&G Library is hosting a StoryWalk® at Warwick Forest event. A StoryWalk® presents the pages from a children's picture book along a trail for walkers to read as they explore the trail. This initiative supports both family literacy, physical activity in our natural spaces, and healthy living. In addition, the book chosen for this specific walk will be an environmental-themed book and offered in both French and English.

Promotion of the event will utilize online advertising through social media and the Library website, traditional media with local newspapers, and direct marketing to Library patrons through handouts at the Library branches. The event is open to the public and COVID-19 protocols will be followed to ensure the event can take place safely. The walk itself is self-guided and participants are encouraged to participate with their family.



Butterflyway Project:

 The SD&G Butterflyway Project is seeking a Community Environmental Outreach Grant from South Nation Conservation to host a Bat House Building Workshop for approximately 25 Butterflyway Project members, in partnership with SNC. Most participants will be building a bat house to erect on their personal property; any extra bat houses built during our workshop will be given to SNC for use on the edges of SNC forests.

The funds received from this grant will go towards purchasing the supplies needed to build the bat houses.

 The SD&G Butterflyway Project is seeking a Community Environmental Outreach Grant from South Nation Conservation to acquire printed materials to support our members (currently 255 and growing every day) in their efforts to promote the goals of the Butterflyway Project in their communities within SD&G.

The funds received from this grant will go towards the printing of flyers as well as coroplast signs with metal stakes. These flyers and signs are to inform, educate, and influence members of the public to become involved in restoring lost habitat for the pollinators.

Chesterville Kayak Club:

The club is hoping to hire a trained instructor to teach proper kayak entry and exit both while on shore and in the water, how to remain calm during self rescue and how to help someone else who has fallen in without panicking, proper paddling skills to avoid injury and basic first aid for typical injuries should they occur.

Any grant money received would go towards this training event which would help keep the member's cost down and allow more members to attend.

Russell Groves Community Association:

The Russell Groves Community Advisory Committee (RGCAC) is built around Stiver Park in Russell, Ontario. The Committee has worked with the Township of Russell to develop a plan that meets all safety requirements and will enhance park usability for the community.

The greatest need in the park is shade. The two-phase plan, spanning 2021-2022, focusses on adding more trees and a permanent structure around the play areas to provide shade to residents. Phase One will commence in spring of 2021 with the planting of one large tree immediately beside the play areas, multiple small trees in an open grass space, and two small existing trees would be relocated. This grant to help alleviate the cost of Phase One of the Stiver Park Project.



Chesterville District Agricultural Society:

The Chesterville and District Agricultural Society has a large plot of land in the town of Chesterville with several different species of trees on it. Our goal is to identify these different species and have an information board by each one. The hope is that people will walk through the area and learn about the different varieties. However, recently we had to removed 10 dead trees from the property due to Ash Borer and Dutch Elm Disease. If chosen, we could spend the money on some new species of trees that we can identify and add to our learning path.

Promotion will be done through social media, the information board and signs at the front gate of the fairgrounds.

Roxborough Agricultural Society

The Roxborough Agricultural Society is looking to plant native caliper-sized trees on the fairgrounds in Avonmore. These trees would add to the beauty of the grounds and provide shade/shelter during various fair events such as the horse shows and calf rally.

The Society's Grounds Committee would be very appreciative of any assistance in determining the best planting location on the site to ensure the best chance of long-term growth. The society will host a photo op and send a write-up the local newspapers to thank SNC for their support.

St. Anne's Catholic School

St. Anne's Catholic School in Cornwall is looking to create a butterfly garden within the school grounds. This garden will be to help students learn about the various types of pollinators and the importance of maintaining a safe habitat for them. The students will assist with the planting, taking care of the garden as well as observing the various butterflies that use this habitat for their home. The project will also help teach the students what is needed to provide food, shelter and breeding habitat for the various types of butterflies.

Funds received from the grant will go towards purchasing dirt, mulch and pollinating plants for the garden. Social media will be used to display photos and keep the community up to date, and a plaque with SNC's logo will be displayed in the garden.

In partnership with South Nation Conservation, we have planned to offer the StoryWalk® at Warwick Forest on Saturday, June 19 and Sunday, June 20. Library staff would be on location both days from 10:00am until 3:00pm to help guide visitors to the start of the trail and answer any questions about the Library. SNC staff may also choose to be onsite during the same time. The book that will be set up on the trail will be "Earth! My First 4.64 Billion Years" by Stacy McAnulty.

Promotion of the event will utilize online advertising through social media and the Library website, traditional media with local newspapers, and direct marketing to Library patrons through handouts at the Library branches. The event is open to the public and COVID-19 protocols will be followed to ensure the event can take place safely. The walk itself is self-guided and participants are encouraged to participate with their family.

Funding for the event will primarily come from the SDG Library, which is funded through the United Counties of SDG. Costs associated with the set up of the StoryWalk® are for the purchase of two copies of the book (in both French and English), the boards to mount the story on, and the stakes for setting up the story. We are seeking a **Community Environmental Outreach Grant** from South Nation Conservation to host a Bat House Building Workshop for approximately 25 Butterflyway Project members interested in participating in this event.

Further to recent conversations with South Nation Conservation staff, our workshop would feature the expertise of Mr. Chris Craig, Senior Forestry Technician, to ensure that our bat houses can be Forestry Standards Councilcertified. During our workshop, most participants will be building a bat house to erect on their personal property; any extra bat houses built during our workshop will be given to South Nation Conservation for use on the edges of SNC forests.

- <1> bundle black asphalt shingles (\$27.97 ea. + HST)
- <250> 7/8" roofing nails (\$3.98/lb + HST)

- <25> performated silicone sheets for one side of the bat house interior (\$18.99/4 + HST)

The Chesterville Kayak Club is applying for a Community Environmental Outreach Grant which would go towards promoting the recreational use of the waterways in a safe way.

The club is based out of Chesterville ON, on the South Nation river, and usually meet to paddle twice a week during the season. Many of our paddles are in the South Nation watershed and members learn about the different launch sites available and can enjoy a wide variety of paddling experiences.

The club was formed in 2010 with membership growing every year. Grant support would go toward water safety and kayak skills training. Many members have had no training and or need refresher tips on proper techniques both on and off the water.

The club is hoping to hire a trained instructor to teach proper kayak entry and exit both while on shore and in the water, how to remain calm during self rescue and how to help someone else who has fallen in without panicking, proper paddling skills to avoid injury and basic first aid for typical injuries should they occur.

Kayaking is a sport for all ages with participants travelling at their own speed, covering various distances, while enjoying fresh air, nature and maintaining social distance but still having people to talk to. Training would give people the confidence to continue enjoying kayaking as safely as possible.

The event is planned to be held in late June depending on weather and possible restrictions due to the Covid-19 pandemic. Location will depend on number of participants so that distance can be maintained – possibly Chrysler as there is a nice big parking lot. Masks would need to be worn while is close proximity to others and list of participants kept for contact tracing.

Any grant money received would go towards this training event which would help keep the member's cost down and allow more members to attend.

The event would be promoted through club members with the South Nation Conservation banner on display throughout. The local newspapers would also be invited to attend.

Re: Tree and Shrub Planting Grant

Dear Communications and Outreach Department,

In 2020, a group of neighbors established the Russell Groves Community Advisory Committee (RGCAC) with one of the goals to make improvements to Stiver Park in Russell, Ontario. Our neighborhood, Russell Groves, is built around Stiver Park. It is at the heart of our community physically and figuratively. The park is owned and maintained by the Township of Russell and is accessed from Stiver and Meadowlark Streets. It continues to provide our community with a safe place to exercise, connect with nature and enjoy the company of our neighbors. During the COVID-19 pandemic we have all found an increased appreciation for the outdoors and, as community leaders, we would like to help provide our neighbors with an enhanced experience in Stiver Park.

We have been working alongside the Township of Russell to develop a plan that meets all safety requirements and will enhance park usability for our community. For the project, RGCAC has received local support and advice from The Russell Kin Club, Jennifer Glenn from Pick, Plant and Prune, the Russell and District Horticultural Society, and members of Eco East.

The greatest need in the park is shade. The park features two sandy areas with commercial play structures suited for children aged 18 months through 11 years old and a paved path connecting adjacent streets. The perimeter of the park has many mature trees however, they do not cast shade over the play areas past early morning in the summer, often making extended playtime unsafe and unenjoyable during hot summer months. It is expected with additional shaded areas in the park available for residents, the community green space will be utilized significantly more.

The two-phase plan, spanning 2021-2022, focusses on adding more trees and a permanent structure around the play areas to provide shade. Phase One will commence in spring of 2021 with the planting of one large tree immediately beside the play areas, multiple small trees in an open grass space, and two small existing trees would be relocated. Phase Two of the plan is scheduled to commence in spring 2022 with the construction of a permanent 12'x12' gazebo structure and further development of the open grass space by continuing to plant mixed vegetation including flowering and edible trees and patches of perennials and shrubs that would attract pollinators and butterflies to the diverse area. The exact plants are to be determined after further consultations with partners.

The RGCAC is applying for a 2021 Tree and Shrub Planting Grant to help alleviate the cost of Phase One of the Stiver Park Project. A quote has been received from Manotick Tree Movers for the cost of the new trees and all associated fees. The cost for Phase One is approximately \$5000 and Phase Two is \$15,000.

Fundraising for the Stiver Park Project began in winter 2020 with additional efforts ongoing through the end of 2022. Upcoming fundraisers include Purdys chocolates, rain barrel sales and Mother's Day baskets filled with local, small business sourced products. It is expected that by June 2021, after only 6 months of fundraising, over \$5000 will have been raised for the project. We also have many volunteers ready to help with in-kind donations and the watering and maintenance of the new plants in the park.

Any part of the project that would need to be done in a group setting would be done in accordance with all COVID-19 regulations (we will respect gathering limits and mask mandates for planting and maintenance purposes). Subject: Request for Approval: 2021 Youth Fish Camp Program Delivery

RECOMMENDATION:

That the Communications Committee approve SNC's program delivery for the 2021 Youth Fish Camps in July and August.

DISCUSSION:

Recreational fishing programs promote sustainable angling practices and encourage residents to explore fishing opportunities at Conservation Areas within SNC's jurisdiction.

2021 marks the twelfth anniversary of SNC's annual Youth Fish Camps. The following program dates are suggested:

- July 7 and 8, 2021 at Cass Bridge Conservation Area, Winchester
- July 14 and 15, 2021 at High Falls Conservation Area, Casselman
- July 21 and 22, 2021 at Jessup's Falls Conservation Area, Plantagenet
- August 4 and 5, 2021 at High Falls Conservation Area, Casselman
- August 11 and 12, 2021 at Cass Bridge Conservation Area, Winchester

SNC traditionally launched day camp registrations in April every year and would be fully subscribed within a month. Registration for 2021 Youth Camps has not yet been launched.

The Province recently announced that day camps can proceed in July and August, provided there are appropriate COVID-19 precautions in place.

Due to scheduling, budget implications, and the health and safety of staff and youth, SNC revised the program delivery plans in 2020, in consultation with local health units (CMN-039/20).

The participation fee was also reviewed in 2020 and it was recommended to maintain the pre-approved rate of \$40/participant (CMN-024/19, CMN-025/20).

Program delivery would include fish identification, fish anatomy/biology, angling strategies, proper catch and release techniques, care and maintenance of fishing equipment, and fishing safety/regulations.



Revised program delivery would include:

- Screening of participants and instructors,
- Reducing number of participants per camp to 15 or 10,
- Maintaining a ratio of 5 participants per instructor,
- Additional PPE, cleaning of equipment and sanitization,
- Each participant provided their own, dedicated set of tackle, line, and rods,
- All other equipment would solely be used by instructors,
- Use the same instructors on Day 1 and Day 2 of camps to reduce risk,
- Consider running program without volunteers (i.e. Ottawa Flyfishers, Water Rangers, etc.),
- Participants will be asked to bring their own lunches,
- Additional seating and rotational programming to support outdoor learning with physical distancing measures.

Work Plans and program materials would need to identify enhanced precautionary measures to manage risks and comply with SNC's COVID-19 Standard Operating Procedures. Advice from health authorities will support final decisions.
