## **1.0 PURPOSE**

The purpose of this document is to outline the proposed plan for South Nation Conservation's (SNC) 75km Challenge in 2022. Some plans and products will need to be confirmed in 2021.

## 2.0 DISCUSSION

A 75<sup>th</sup> Anniversary Work Plan was prepared by staff through consultations with the Communications Committee and was adopted by the Directors in September 2021 (BD-166/21). The signature event planned for the 75<sup>th</sup> anniversary is a 75km Challenge.

Watershed residents and visitors alike will be encouraged to visit SNC's Conservation Areas throughout the year (January to December 2022) and track their distance; whether they snowshoe, ski, walk, hike, run, or paddle, etc. More details are shown in Appendix A.

It's not a race – participants can do it on their own time and at their own pace. To be eligible for a chance to win monthly and a grand prize, participants must register and document their progress. #### **3.0 TIMELINES**

It is anticipated that minimal staff support will be required to oversee the Challenge once the event has been launched (social media, participant packages, monthly draws).

As the frequency of visitors to Conservation Areas continues to increase, SNC plans to modernize signage for best practices in accessibility, bilingualism, and legibility, creating a consistent and recognizable brand across each of its properties.

SNC staff have completed a sign audit of all signs on SNC owned property and evaluated their effectiveness to support the development of new Sign Guidelines.

Sign types including (but not limited to) Property Identification, Trailhead Maps, Directional, Informational, and Cautionary will be redesigned and reinstalled in every SNC Conservation Area in adherence with new Sign Guidelines.

Work has included an initial signage audit, research on best practices, development of consistent content, graphic design consultation, and will include translation, printing, and installation.

SNC is seeking Committee feedback to further refine the Design Guide to ensure signs use the least costly, most long-lasting materials and that their design content is accessible.
