#### **RECOMMENDATION:**

The Board of Directors approve the submission to the Ministry of Northern Development, Mines, Natural Resources and Forestry under the 2022-2023 Water and Erosion Control Infrastructure (WECI) program at approximately \$80,000 for the Chesterville Dam Winter Water Levels Assessment project.

#### **DISCUSSION:**

South Nation Conservation (SNC) annually applies to the Ministry of Northern Development, Mines, Natural Resources and Forestry's (NDMNRF) Water Erosion Control Infrastructure Program (WECI). The program provides up to 50% cost-share funding for capital projects associated with water control and erosion control structures.

The call for 2022-2023 submissions to the WECI program for Conservation Authorities was received on January 17, 2022, and the deadline to submit project proposals is February 11, 2022.

Following Board approval, SNC staff will apply for the following project:

If approved, funding received from the Province must be matched by SNC, \$40,000 each partner, and project must be completed by March 15, 2023.
