DISCUSSION:

South Nation Conservation (SNC) is committed to the following actions as part of Conservation Ontario's Timely Review Taskforce:

- Improve Client Service and Accountability;
- Increase Speed of Approvals, and
- Reduce Red Tape and Regulatory Burden.

This initiative includes annual reporting on timelines and service standards for Section 28 permits (under the *Conservation Authorities Act*). The reports are provided to SNC's Board of Directors, posted on SNC's website, and submitted to Conservation Ontario.

The timelines for both Ministry Northern Development, Mines, Natural Resources and Forestry (MNRF) and Conservation Ontario (CO) service standards are provided below.

Timeline Reporting

The MNRF service standards are 30 (calendar) days for minor applications and 90 days for major applications from the date the application is deemed complete.

Major applications are highly complex, requiring full technical review, and need to be supported by comprehensive analysis or those that do not conform to existing CA Board-approved Section 28 policies.

The CO service standards are 21 days for minor applications, 28 days for major applications, and 14 days for routine applications. There are additional time allowances for resubmissions.

Permit Timeline Analysis and Improvement

SNC received an exceptionally high number of applications in 2021, partially due to a jurisdiction expansion along the Ottawa River. Processing applications was also impacted by on-going adjustments related to the COVID-19 pandemic (receiving applications, coordinating payments, completing site visits) and increased complaints and occurrences. This provided additional incentive to increase efficiency to maintain review timelines.

SNC implemented several improvements to streamline permit reviews:

- Modified database to allow online applications to translate directly to our file management system.
- Trained and appointed additional staff to support issuing permits in 2022.
- Updated regulations policies to clarify permit requirements and reduce unnecessary submissions.
- Created a "Frequently Asked Questions" resource for Permits on the website.
- Ability to 'pause' timelines on file management system when additional information is required to address errors or gaps with technical information.
- Integrated a new process which allows staff to draft permits and flag technical review ahead of time.
- Implemented administrative improvements including automatic email responses for applications, permits, and payment instructions.
- Continued process improvements for a dedicated inbox (<u>regulations@nation.on.ca</u>) which supports the administration of applications, questions, and occurrence reports.

RECOMMENDATION:

The Board of Directors approve the Programs and Services Inventory;

AND FURTHER THAT the Programs and Services Inventory be circulated to participating Municipalities and the Ministry of Environment, Conservation and Parks.

DISCUSSION:

The Ministry of Environment, Conservation Parks ("MECP") implemented the first phase of *Conservation Authorities Act* regulations in October 2021. The regulations require each conservation authority have a transition plan in place by December 31st, 2021 and create an inventory of programs and services by February 28th, 2022. These documents initiate consultations with member municipalities [to take effect January 1, 2024].

The Board approved SNC's Transition Plan November 18, 2021. Staff circulated the Transition Plan to member municipalities and MECP and posted it on SNC's website.

SNC's Program and Services Inventory (the "Inventory") is attached. It lists programs and services SNC delivers as of February 2022 and programs and services SNC intends to deliver in the future.

The Inventory includes sources of funding for each program and service and identifies programs and services as one or more of the following:

- **Category 1: Mandatory programs and services** required by regulation. These programs are funded through municipal levy.
- Category 2: Municipal programs and services provided at the request of a municipality. These programs can be funded through government and other agency grants and/or municipal funding under a memorandum of understanding (MOU) or agreement with the municipality.
- Category 3: Other programs and services the Conservation Authority determines are advisable. These programs can be funded through self-generated revenue, user fees, government and other agency grants, donations, etc. Any use of municipal funding requires an agreement and would be subject to cost apportionment.





Phase 2 Regulations have not been released. This phase will include a review of the two current levies regulations (O. Reg. 670/00 "Conservation Authority Levies"; O. Reg. 139/96 "Municipal Levies") and a Conservation Authority Fee Policy.

The Inventory includes estimates and assumptions on: costs; cost allocations; and revenue distribution and is subject to change as costs are refined and as new regulations are released.

The Inventory is intended to be an evolving document. Refinements are anticipated during municipal consultation.

The Inventory will be circulated to member municipalities and the Ministry of Environment, Conservation and Parks. It will also be available on SNC's website.

Chart A: Programs and Services Inventory List - Categories, Descriptions, Category Rationale

Chart A provides an overview of the programs and services SNC currently offers. The list generally preserves the current financial reporting structure used for presenting the annual budget, financial updates, and internal financial management reports.

Each program and service is categorized by criteria identified under the *Conservation Authorities Act* and regulations. Programs that fall into Category 1 have a corresponding citation to Ontario Regulation 686/21 "Mandatory Programs and Services".

Comments:

- Phase 2 regulations have not been released and are expected to provide direction on allocation of administration and overhead costs.
- SNC Corporate Services costs represent administration overhead costs and are shown separately in the inventory. These costs have not been fully allocated to mandatory program areas pending release of Phase 2 Regulations.
- Some program/service may change between category 2 and 3 depending on discussions with municipalities

New deliverables identified in the regulations are included in the Inventory:

- 1. Operations Plan Natural Hazard Infrastructure;
- 2. Asset Management Plan Natural Hazard Infrastructure;
- 3. Conservation Area Strategy;
- 4. Land Inventory;
- 5. Watershed-based Resource Management Strategy.





Chart B: Inventory of Programs and Services - Costs and Funding Sources

Chart B provides an overview of costs and identifies percentage of revenue sources. The Regulation requires the average annual cost of each program and service be provided based on a five-year average or another value that best describes the cost of the program that is permitted provided it is justified.

SNC has included program and services costs from the 2022 budget. With high levels of growth in the watershed, corresponding demand for SNC programs and Services, and current levels of inflation, the 2022 budget provides a more accurate estimate of costs for 2024 programming than historical five-year averages.

This chart includes a breakdown of the percentage of revenue supporting the program and service costs. Revenue categories include: municipal levy; municipal MOUs/agreements under regulations; provincial and federal and other municipal funding; self-generated revenue, specific to program (i.e. user fees); self-generated revenue that has been allocated from other program area revenue; and reserves.

Comments:

- Revenue percentage distributions will change as costs fluctuate.
- Estimated percentages for Municipal MOUs/agreements may change as negotiations with municipalities are completed.
- Costs identified will be refined over time and subject to change by 2024.
- Reserves are shown as a distinct revenue source. This highlights where reserves are used to fund programs as part of an overall deliberate strategy of drawing on reserves that were generated by setting aside funding from prior years and now accessing reserves as needed. The Source Water Protection Program is funded entirely by the province.

Chart C: Inventory of Programs and Services - Category 2: Details of Municipal Agreements

Chart C identifies the programs and services SNC provides on behalf of municipalities via agreements. This chart will be updated as new and updated Category 2 agreements are negotiated with municipalities.

Chart D: Inventory of Programs and Services - Category 3: Information Requirements

Chart D identifies Category 3 programs and services and identifies whether the program/services is financed through municipal levy, and what funding sources will be used to support the program/service as of January 1, 2024.





Regular progress reports on the Inventory of Programs and Services must be submitted to the MECP and posted on SNC's website. As SNC moves through the transition period, it is expected that program and service costs will be refined.

FINANCIAL IMPLICATIONS/ADHERENCE TO SNC POLICY:

Compliance with Budget:

Preliminary analysis suggest programs and services can be delivered without a significant change in total municipal levy support required compared with the current levy funding model. SNC maintains a Stabilization Reserve to bridge programs where minor funding gaps exist.

RECOMMENDATION:

The Board of Directors receive and file the update on the Ministry of Environment, Conservation and Parks Phase Two Regulatory and Policy Proposal Consultation Guide.

DISCUSSION:

The Ministry of Environment, Conservation and Parks ("MECP") has released a consultation guide describing the second phase of regulatory proposals under the *Conservation Authorities Act* (the "Act").

The consultation guide is posted on the Environmental Registry of Ontario (notice number 019-4610) with a public comment period until February 25, 2022. MECP hosted webinars for municipalities and conservation authorities in early February where they provided an overview of the proposals.

1. Proposed Municipal Levies Regulation

Proposed regulations will govern the apportionment of Conservation Authority (CA) municipal levies ('operating expenses' and 'capital costs') as well as budgetary matters in general.

A new municipal levies regulation will consolidate the two current levies regulations and adapt the three current methods of apportioning CA expenses/costs through municipal levy into the new categories of CA programs and services. Namely:

- modified current property value assessment method
- by agreement between the CA and municipality
- as determined by the total benefit afforded to all the municipalities and the proportion of the benefit afforded to each of the municipalities

The new regulation will carry forward existing voting methods (i.e., the 'one member, one vote' and 'weighted vote').

Provisions will also govern CA budget matters including the process authorities must follow when preparing a budget, the consultations required, and the rules and procedures governing budget meetings including quorum and voting on the budget.





2. Proposed Regulation for Determining Amounts Owed By Specified Municipalities

Provisions in the Act will be proclaimed to allow CAs to levy participating municipalities and 'specified municipalities' for mandatory programs and services related to the CA's responsibilities under the *Clean Water Act, 2006.* A 'specified municipality' is a municipality designated by regulation for a source protection authority/area under the *Clean Water Act, 2006* but is outside a CA area of jurisdiction.

A new regulation will identify the specified municipalities and identify methods available to CAs to determine the costs specified municipalities may need to pay. The process for engaging specified municipalities on levies under the *Clean Water Act, 2006* is proposed to be similar to the levy process and budget process for participating municipalities under the *Conservation Authorities Act*.

3. Proposal For Minister's List of Classes Of Programs And Services For Which A Conservation Authority May Charge A Fee

CAs may only charge fees for services approved by the Minister. The current list is set out in the provincial *Policies and Procedures for the Charging of Conservation Authority Fees* (June 13, 1997)

Provisions of the Act will be proclaimed allowing the Minister to determine a list of 'classes of programs and services' a CA may charge a fee for, publish the list, and distribute it to each CA. CAs would be permitted to charge a fee for a program or service only if it is set out in the Minister's list of classes of programs and services. Once a CA is granted the power to charge a fee for a program and service, the CA may determine the fee amount to charge. These provisions will also require CAs to publish a fee policy and schedule as well as a maintain a policy to reconsider a fee at the request of an applicant.

The Minister's classes of programs and services will capture 'user' fees. This includes use of a public resource (e.g., park use permit) or the privilege to do something (e.g., permission to develop in a regulated area).

4. Regulatory Proposals to Increase Transparency of Conservation Authority Operations

A proposed regulation will require CAs to maintain a governance section on their website where the following information is consolidated:

- CA members and their contact information;
- administrative by-laws;
- draft and final budgets;
- agreements with municipalities; and
- board meeting schedule.




FINANCIAL IMPLICATIONS/ADHERENCE TO SNC POLICY:

Staff will continue its work with member municipalities and Conservation Ontario to undertake regulatory changes and meet all implemented timelines. Further updates on regulations and regulatory proposals will be provided to the Board as they are released.

The Board of Directors receive and file the Ministry of Environment Conservation and Parks agricultural sector representative appointment update.

DISCUSSION:

Recent amendments to the *Conservation Authorities Act* enables the Minister of Environment, Conservation and Parks ("MECP") to appoint an agricultural sector representative to boards of conservation authorities ("CAs").

Appointed agricultural representative may participate in CA meetings in a manner similar to municipal appointed representatives but are prohibited from voting on decisions related to:

- enlarging a CA's area of jurisdiction;
- amalgamating a CA with another CA;
- dissolving the CA; or
- budgetary matters.

On February 7, 2022, MECP advertised agricultural representative positions for each of the 36 Conservation Authorities. A copy of the South Nation Conservation posting is attached. The deadline for applications is February 21, 2022. Appointment terms will be up to four years.

FINANCIAL IMPLICATIONS/ADHERENCE TO SNC POLICY:

<u>Compliance with Budget</u>: The Agricultural Representative is advertised as being entitled to a \$150 per diem plus reimbursement for travel expenses. This expense is expected to be covered by the province.

<u>SNC Policy Adherence</u>: Minister discretion to appoint agriculture sector representatives is described in subsection 14(4) of the *Conservation Authorities Act*. Staff will undertake necessary amendments to SNC's Administrative By-laws for Board review and approval should an applicant be chosen.

RECOMMENDATION:

The Board of Directors approve entering into a planning partnership with the United Counties of Stormont, Dundas and Glengarry and Raisin Region Conservation Authority for the purpose of reviewing severance applications in the Township of South Stormont and the Township of North Stormont.

BACKGROUND:

The United Counties of Stormont, Dundas, and Glengarry (SDG) coordinates land severance applications on behalf of local municipalities. Conservation Authorities (CAs) review severance applications with respect to Natural Hazards and Natural Heritage under the *Planning Act.*

Conservation Authorities also review severances through agreements with municipalities (e.g., septic review). Conservation Authorities charge a fee for this service on a cost recovery basis and in accordance with their board approved fee schedules. A portion of the fee collected covers costs related to a site visit.

DISCUSSION:

The Townships of North Stormont and South Stormont (the "Townships") are partner municipalities of Raisin Region Conservation Authority (RRCA) and South Nation Conservation (SNC). Due to SNC's Building Code Part 8 responsibilities, severance applications in those areas of the Townships within RRCA jurisdiction are charged a review fee from both CAs.

The current review fees are \$490 from each CA (\$980 total). RRCA performs a site visit and comments on Natural Hazards and Heritage; and SNC performs a site visit and comments on private sewage servicing.

SDG, RRCA, and SNC staff have met to discuss how to better serve the Townships' residents. A planning partnership was proposed where SNC coordinates the review of severance applications within the Townships. This means a single site visit; reduced circulation and administration; and one comprehensive comment letter. SNC would charge the





applicant a single severance review fee (\$490) plus a RRCA natural hazard screening fee (\$85). The result would be a net savings of \$395 for applicants.

The screening fee will support RRCA staff review of applications related to outstanding violations, permitting requirements, and local knowledge of the area.

The RRCA Board of Directors approved this partnership at their January 2022 meeting. Next steps include working with SDG to update circulation and fee collection in these municipalities.

FINANCIAL IMPLICATIONS/ADHERENCE TO SNC POLICY:

Compliance with Budget:

The planning advisory services are fee-for-service according to the Board of Director's approved Fee Schedule. There is no anticipated impact to the 2022 Budget.

SNC Policy Adherence:

Existing Memorandums of Understanding are in place with municipalities that cover planning advisory services. These Memorandums of Understanding will be updated in 2022.

RECOMMENDATION:

That the Board of Directors approve RRCA staff to enter into a planning partnership with South Nation Conservation for the purpose of reviewing severance applications in the Township of South Stormont and the Township of North Stormont.

BACKGROUND:

The United Counties of Stormont, Dundas, and Glengarry coordinates land severance applications on behalf of local municipalities. Conservation Authorities review all severance applications with respect to Natural Hazards and Natural Heritage under the Planning Act. Conservation Authorities may also review severances through various other programs as negotiated with each municipality (for example, South Nation Conservation (SNC) also conducts a septic review for several municipalities). Conservation Authorities charge a fee for this service on a cost recovery basis. A portion of the fee collected is allocated to a site visit.

DISCUSSION:

Severance applications within the portions of South Stormont and North Stormont that fall within the Raisin Region Conservation (RRCA) jurisdiction are charged a review fee from both Conservation Authorities (CA). The current review fees are \$490 from each CA. The applicant is therefore charged \$980 total from both CAs. RRCA performs a site visit and comments on Natural Hazards and Natural Heritage; and SNC performs a site visit and comments on sewage disposal.

Staff from the RRCA met with staff from United Counties of SDG, and SNC to discuss how to better serve our area residents. It was agreed that in the interest of reducing expenses to applicants, that a single CA in these overlapping areas could perform most of the work. A planning partnership was therefore proposed such that SNC could review the Natural Hazard and Natural Heritage aspects of severance applications within the Townships of North Stormont and South Stormont.

The benefit of this approach would be that a single site visit would be required. The end-result to the applicant would be a single severance review fee charged by SNC (currently \$490), plus a screening fee charged by RRCA (currently \$85); this would result in a net savings of \$395 for the applicant. The screening fee would allow RRCA staff to review the application with respect to outstanding violations, existing permits, the requirement of future permits, as well as to add comments related to local knowledge of the area.

RECOMMENDATION:

The Board of Directors approve the updated Regulation Policies pursuant to Section 28 of the *Conservation Authorities Act*.

DISCUSSION:

South Nation Conservation's ("SNC") regulation under Section 28 of the Conservation Authorities Act is titled Ontario Regulation 170/06 South Nation River Conservation Authority: Development, Interference with Wetlands and Alteration to Shorelines and Waterways Regulation. Ontario Regulation 170/06 grants SNC the authority to regulate development in river or stream valleys, wetlands, shorelines, and hazardous lands to protect people and property.

SNC's Regulation Policies (the "Policies") interpret Ontario Regulation 170/06 to guide the issuance of Section 28 permits for development activities in regulated areas. The Policies were last updated in August 2019.

The updated Policies incorporate lessons learned and feedback provided by various partners. The Policies continue to reflect SNC's commitment to work collaboratively with landowners, municipal partners, and the public.

Changes in this housekeeping update include: a new policy for the construction of boardwalks in provincially significant wetlands, a revised section for the Ottawa River shoreline flooding hazard, and an improved description of the riverine erosion hazard. The Policies also clarify that:

- certain marine structures may be permitted in a floodplain where there is no habitable living space;
- buildings in the floodplain may be replaced so long as the number of dwelling units is the same or less and the hazard risk is not increased, and
- retroactive permits may only be considered where unpermitted projects meet, or can be reasonably modified to meet, SNC's Section 28 Regulation Policies.

A copy of the updated "Regulation Policies Pursuant to Section 28 of the *Conservation Authorities Act*, R.S.O. 1990, c. C.27 - Ontario Regulation 170/06: Regulation of Development, Interference with Wetlands and Alterations to Shorelines and Watercourses – February 2022" is posted to the Board's Members page for review.





Partner municipalities and will be circulated copies of the updated Policies. The Policies are publicly available on SNC's website in accordance with Conservation Ontario's Client Service and Streamlining Initiative for High Growth Conservation Authorities.

FINANCIAL IMPLICATIONS/ADHERENCE TO SNC POLICY:

The Board of Directors may approve housekeeping updates to existing policies from time to time.

There are significant pending amendments to the Policies related to Ottawa floodplain mapping and the potential regulation of locally significant wetlands at the request of certain member municipalities. These amendments will be subject to broad stakeholder engagement.

A workplan was prepared to identify initiatives that will help recognize this milestone and highlight how SNC's water resource management and conservation lands stewardship have helped form and contribute to a Living Natural Legacy (BD-166/21).

An Anniversary Guide is attached and includes some anniversary initiatives along with regular programming that will be adjusted to help highlight the 75th Anniversary, including:

RECOMMENDATION:

DISCUSSION:

South Nation Conservation (SNC) owns and manages several day-use conservation areas and river access points throughout its jurisdiction with the support of member municipalities. These spaces help people safely step outdoors and into nature, with an added benefit of helping people connect to and experience their local environment.

SNC has continued its work with member municipalities and local health agencies to keep as many conservation areas open to the public as possible throughout the COVID-19 Pandemic. Conservation areas had another records year in 2021 with over 196,000 recorded visitors at parking lot and trail monitoring sites. Although visitation was up, SNC did not see the overcrowding observed in other regions of the province.

The record setting visitation came with an increase in litter, vandalism, trespass, and property damage for some parks. To ensure the most enjoyable and safe user experience, staff visited some properties several times a week. More frequent maintenance tasks included repairing damaged trails and access points along with undertaking off trail restoration efforts and temporary closures to protect forest health and biodiversity.

Introduction

South Nation Conservation (SNC) owns and manages 174 properties throughout its jurisdiction in Eastern Ontario, constituting approximately 13,000 acres of land. Of these, 15 properties are designated as day-use Conservation Areas (CAs).

SNC manages and maintains these areas to offer year-round recreational opportunities for residents and visitors including birding, boating/canoeing/paddling, fishing, geocaching, hiking/walking, picnicking and horseback riding. Other forested properties offer passive recreation opportunities including, hunting, trapping, sustainable harvesting, and lease opportunities.

In 2021, SNC experienced an unprecedented increase in park usage at its day-use areas due to the COVID-19 Pandemic. With increased restrictions on travel and indoor activities, recreational users sought out local amenities, which promoted safe outdoor spaces for recreational use. As an essential service, SNC opened and maintained its Conservation Areas in accordance with Provincial Emergency Orders and with guidance from local Health Units.

SNC manages its Conservation Areas with support of municipal and county partners, all publicly accessible Conservation Areas require management agreements with municipal partners.

The COVID-19 Pandemic brought increased visitor usage, as well as increased challenges for park and natural spaces maintenance. SNC greatly appreciates feedback from all recreational users, as well as the continued support from the public, Board and Committees, volunteers, municipalities, and funding partners.

Objectives of the Conservation Areas Monitoring Program

Beginning in 2013, SNC began collecting weekly data from car and trail counters. To date, SNC has installed counters in all its day-use Conservation Areas. Car counters record each vehicle as it enters the CA entrance (counters assume that there are two visitors per vehicle, on average). Trail counters record individual visitors as they pass by a designated location along the trail. This data provides accurate insight on visitation and trail use at monitored locations.

Objectives of the Conservation Area Monitoring Program:

- 1. Gauge public use of SNC Conservation Areas;
- 2. Guide improvements to CA infrastructure based on usage; and
- 3. Communicate and build support for SNC's Conservation Areas.

Overview: Conservation Areas Monitoring Program

Data Collection

SNC began its monitoring program in 2013 with the implementation of one vehicle counter and one trail counter. Counter deployment corresponds with park opening dates and trail conditions.

Counters are serviced monthly to download data (car counters) and manually record results (trail counters).

In 2016, SNC purchased additional trail and car counters to increase its coverage to include all CAs (see Figure 1). The new counters allow for collection year-round where CA's remain open. The counters also allow for extended deployment periods, effectively limiting maintenance requirements and improving monitoring results.



Figure 1. Locations of car and trail counters at SNC Conservation Areas.

Conservation Area Network

To maintain an overall understanding of recreational use of CAs, counters are installed at each CA corresponding with their opening. Data helps SNC understand trends and peaks in visitation and informs seasonal maintenance needs.

The CAs are organized into two main categories to inform the type of counter needed and timing of deployment: recreational trails, and picnic & river access locations.

Trail counters were placed in strategic locations to ensure concealment and effectiveness. Counter placement is occasionally adjusted to respond to vandalism issues.

Conservation Area Usage Results

Recreational Trails

SNC maintains approximately 25 km of trails at 8 CAs throughout its jurisdiction. Usage varies amongst the recreational trails, due to location, trail features, user groups and interests, and seasonal trail conditions.

SNC performs weekly inspections on its recreational trails to ensure safe and enjoyable access for its users. Routine maintenance occurs annually, with planned replacements occurring when assets approach end of life cycle. Data collected allows SNC to assess the amount of traffic trail systems experience throughout different seasons and years.

The following table outlines recorded visitor totals for recreational trails monitored between 2014-2021.

Note that trails are temporarily closed during tree management projects which can impact recorded visitation.

Picnic & River Access Conservation Areas

SNC maintains picnic and river access at 6 CAs throughout its jurisdiction. These CA's operate seasonally between May and November annually. Of these 6 CA's, 4 are river access locations complete with boat launches, docks, and trailer parking.

Usage varies due to location, amenities available, user groups, and interests. SNC performs weekly inspections of its picnic and river access CAs during the operating season to ensure safe and enjoyable access for its users.

The following table outlines recorded visitor totals for picnic and river access areas monitored between 2014-2021.

Note that municipal partner sites managed through agreement are not currently monitored (Chesterville Waterfront and Boat Launches, Embrun Boat Launch, Spencerville Boat Launch).

New Conservation Area Development

Since 2013, SNC has collected information relating to Conservation Area visitor usage to help guide the management of these public spaces and to help determine the level of effort required to manage newly opened spaces.

Recent property donations have allowed SNC to expand its Conservation Area network:

- First in 2014 with the opening of the Reveler CA in North Stormont which features 3 km of walking trails through a 99-acre natural grassland and hardwood forest.
 - Property donated to SNC in 2012 by Ray Reveler.
- Followed in 2019 with the opening of the Oschmann Forest CA in North Dundas which features a 1.2 km walking trail through an 18-acre woodlot which is now the home of SNC's Maple Education Program.
 - Property donated to SNC in 2017 by George Oschmann.
- Followed in 2021 with the opening of the Mill Run Conservation Area in Augusta which features a small trail, picnic area and river access site on a 9-acre property which will provide recreational access to the South Nation River. A car counter will be installed for the 2022 season.
 - Property donated to SNC in 2021 by the Township of Augusta.

Visitation trends at new sites helps inform future management and maintenance requirements.

No municipal agreements have been established for the three most recent parks that have been opened to the public. Agreements should be negotiated after a maintenance baseline is established to determine the required level of effort.

SNC will be working with the Township of North Dundas (for the Oschmann Forest) and the Township of North Stormont (for Reveler) in 2022 to update park maintenance agreements to ensure that these sites can continue to be maintained year-round.

Conservation Areas Usage Summary

An overview of the annual monitored usage between 2014-2021 and some notes on data collection is outlined below.

Information collected throughout 2013-2015 varied and was collected from May-November at select parks. In 2016, SNC deployed counters at all CAs to ensure full coverage.

W.E. Burton and J. Henry Tweed are consistently the most visited recreational trails. Both are urban parks and act as a travel corridor for people living within subdivisions to the downtown core of the village. J. Henry Tweed was also closed in December 2021 to support hazard tree management needs, which impacted the 2021 visitation numbers.

Jessup's Falls experiences the highest use for river access parks, with an average visitation of 13,800 users annually between 2016 and 2019. In 2021, this park experienced an estimated 26,042 visitors. This park features a boat launch, mature trees, forested areas and trails, picnic shelter, barbeques, washroom facility, and access to 600 meters of shoreline fishing opportunities.

Between 2014 and 2019, SNC recorded, on average, 80,363 visitors at Conservation Areas.

In 2021, SNC welcomed an estimated 196,897 visitors to its Conservation Areas, marking a record since SNC began monitoring park usage, and increase of 19,453 over 2020.



The following figure shows the recorded use from 2014-2021.

Figure 3. Annual Monitored SNC Conservation Area Visitation (2014-2020).

Understanding annual and monthly visitor trends help inform visitor behaviour and appropriate resource needs to manage visitation and maintenance requirements. Data also supports park opening and closing dates through municipal agreements and can inform whether an area should be designated as a public Conservation Area.

Visitation remained consistent at most CA's throughout the summer with a small decline in the Fall and into the Winter. Regular visitation continued during peak COVID-19 infection rates.

Note that sites that support picnic and river access often do not contain recreation trails and are only open and maintained seasonally by SNC between May and November.

Summary of Observations

SNC completes weekly inspections at all Conservation Areas while facilities are open to the public.

In 2018, SNC began documenting inspection records through an online Survey 123 application. This smartphone app has allowed staff to document site conditions digitally, enabling quick retrieval of information and effective response to recreational user concerns or comments.

In 2021, a total of 570 inspections were completed, compared to a total of 502 in 2020.

SNC plans to expand the app to track maintenance records, specific to work completed at each CA. Inspections require an in-depth assessment of each CA to evaluate general condition and mitigate any safety concerns. It should be noted that some inspection reports were not completed at areas while maintenance work was being completed and staff were on site. Future planned app updates will help address this.

General staff observations are summarized below from site inspections in 2021.

- Recreational usage increased at most CAs, especially at sites with recreational trails. Sites with picnic areas and no trails experienced a small decrease in visitation during COVID-19 Stay-At-Home Orders.
- Impacts to infrastructure and natural ecological features noted at some CAs, requiring partial closure of trail networks, and restriction of public access to natural areas.
- Requirement for increased park inspections throughout summer months to address general maintenance requirements.
- Damage to trail surfaces in highly visited areas.
- Parking capacity concerns at some CAs with limited parking.
- Continued higher than normal usage at previously low-use CAs.
- Increased vehicle traffic at urban CA's which traditionally experienced local foot traffic.
- Decreased use of shared surfaces.
- Increased use of non-designated trails. Some temporary trails were also created by visitors.
- Increased public input on maintenance and CA deficiencies. Increased volume of inquiries on CA management.
- Increased dumping of household garbage.
- Animal-proof waste collections bins had limited use. Need to install additional waste bins.
- Usage of Conservation Areas during seasonal closures. Increase in trespassing.
- Requirement for increased signage, trailhead maps, and COVID-19 precaution signs.



Recommendations

The following recommendations are provided to support the monitoring program objectives:

Objective 1 - Gauge Public Use of Conservation Areas

- Purchase additional counters to evaluate public use of specific infrastructure (i.e., unofficial trail usage, bridge, and boardwalk usage, etc.).
- Continue monitoring all Conservation Areas during open season; consider installing counters during seasonally closed sites to monitor use, when feasible.

Objective 2 - Guide Conservation Area Improvements

- Develop a Conservation Area Strategy for all SNC Conservation Areas and lands.
- Develop property maintenance standards for public Conservation Areas.
- Compare annual equipment rental costs with future equipment needs to evaluate the need for equipment purchases to continue maintaining parking lots, trails, and to aid in tree removals and maintenance requirements.
- Work with municipal by-law officials to support increasing enforcement needs.
- Promote sustainable and responsible stewardship of SNC natural spaces and Conservation Areas.
- Use vitiation monitoring to guide future development and improvements.
- Use information in funding applications to secure investments in Conservation Area maintenance and improvements.

Objective 3 - Communicate and Build Support for SNC Conservation Areas

- Support updates to Memorandum of Understandings with municipal partners.
- Distribute collected information through municipal workplans or direct reporting.
- Communicate results to Board members and SNC staff monthly.
- Deliver presentations to Municipalities on Conservation Area use and management.
- Collaborate with municipal partners to jointly plan and fund capital projects in Conservation Areas.

DISCUSSION/ADHERENCE TO BUDGET:

SNC delivers many Program and special projects on behalf of our member municipalities and partner organizations. SNC has provided program coordination and financial management for many of these Programs for years.

This report provides a breakdown for each program/special project and its associated funds.





1. Eastern Ontario Water Resources Program (EOWRP)

SNC has delivered the EOWRP (formally Eastern Ontario Water Resources Committee) on behalf of its partners since 2003. Several EOWRP projects were approved in 2021 and will be completed in 2022; encumbered funding has been carried forward to the 2022 EOWRP budget.

EOWRP included in 2022 SNC budget under Resource Management: Partner Programs: Water on pages 18-19. Special projects have a separate budget sheet as per below.

a) UCPR Floodplain Mapping Project

The United Counties Prescott and Russell (UCPR) is providing \$25,000 in 2022 to support floodplain mapping projects within UCPR's jurisdiction. Project included in the 2022 SNC budget under Approvals: Projects: United Counties of Prescott-Russell – Floodplain Mapping on pages 58-59.

- b) City of Ottawa South Bear Brook Catchment Study The City of Ottawa provided \$25,068 to the South Bear Brook Catchment Study in 2021; a total of \$17,068 was spent, the remainder (\$8,000) has been carried forward to complete the project in 2022. Project included in the 2022 SNC budget under Approvals: Projects: Planning Studies on pages 68-69.
- c) City of Ottawa: Lagoon Effluent Tree Irrigation and Evapo-transpiration Study An EOWRP grant total of \$3,000 was approved to the University of Ottawa to support the Study. Funding has been carried forward for payment of this grant in 2022. EOWRP funding included under Resource Management: Partner Programs: Water on pages 18-19.
- d) City of Ottawa: South Nation Conservation Assessing future flood vulnerability in the South Nation River Watershed
 An EOWRP grant total of \$11,800 was approved to the South Nation Conservation Assessing future flood vulnerability in the South Nation River Watershed project in 2021. The project started in 2021; a total of \$2,800 was spent and the remaining \$9,000 has been carried forward to the 2022 Budget for project completion. Project is included in the 2022 SNC budget under Resource Management: Water Response Programs on pages 14-15.

2. UCPR Woodlot Advisory Service (WAS)

The United Counties of Prescott and Russell (UCPR) is providing \$20,000 for the delivery of WAS in their Counties. The funding will focus on grants of up to \$500 for







woodlot owners to have a forest management plan developed by a qualified consultant. SNC has delivered the Woodlot Advisory Service in UCPR for the past ten years. Funding is included in 2022 SNC budget under Resource Management: Partner Programs: Forests on pages 16-17.

3. SDG Roadside Tree Program

The United Counties of Stormont, Dundas and Glengarry (SDG) is providing \$25,000 for planting of roadside trees along SDG County roads. Funding will cover SNC staff time to coordinate site selection and planting plans, purchase trees, and contracted services for planting, if required. This is SNC's twelfth year delivering the Program for SDG. Funding is included in 2022 SNC budget under Resource Management: Partner Programs: Forests on pages 16-17.

4. SDG Woodlot Advisory Service (WAS)

The United Counties of Stormont, Dundas and Glengarry (SDG) is providing \$35,000 for the delivery of WAS in their Counties in 2022. The funding will cover free site visits to woodlot owners by a forest technician, grants of up to \$500 for forest management plans, and communications and outreach for the service. SNC has delivered the Woodlot Advisory Service in SDG since 2018. Funding is included in 2022 SNC budget under Resource Management: Partner Programs: Forests on pages 16-17.

5. City of Ottawa Special Levy Programs

SNC delivers several programs on behalf of the City of Ottawa and in partnership with the Mississippi Valley (MVCA) and Rideau Valley (RVCA) Conservation Authorities. These programs are funded via a Special Levy from the City of Ottawa.

These Programs are included in the 2022 SNC Budget under Resource Management: Partner Programs: Forests on pages 16-17 (Ottawa Ash Tree Replacement Program) and Resource Management: Partner Programs: Water (Ottawa Rural Clean Water Program) on pages 18-19. Please note, 2022 Budget amounts do not include 2021 carry over of encumbered grant funds to be paid in 2022.

A separate report for 2022 City of Ottawa Special Levy funding will be brought to the Board in May 2022 pending final approval by City Council.

a) Ottawa Ash Tree Replacement Program

The Ash Tree Replacement Program was developed and launched in 2018. The Program provides cost-share funding for landowners to remove trees infested with the Emerald Ash Borer and replace them with native trees. The Program is delivered City-wide by SNC on behalf of the City, MVCA, and RVCA.





Approved projects from 2021 have until June 30, 2022 to be completed, a total of \$148,874 has been carried over from 2021 for these approved projects; encumbered funds will be disbursed as projects are completed in 2022.

b) Ottawa Rural Clean Water Program

Approved projects from 2021 have approximately one year from date of approval to be completed, a total of \$243,371 has been carried over from 2021 for these approved projects; encumbered funds will be disbursed as projects are completed in 2022.

SNC has delivered the Program, in partnership with RVCA and MVCA, since it started in 2000. As the Program lead, in addition to financial administration, SNC provides coordination for delivery, Program Committee meetings, and communications between the Program partners.

6. Imagery Acquisition (LiDAR)

SNC is leading a Light detecting and ranging (LiDAR) acquisition project for Eastern Ontario. The partnership includes five other conservation authorities and forty-nine municipalities (upper and lower tiers). This multi-year project began in 2021 and will be completed in 2022.

Several of the partners provided their contribution to the project in 2021, unspent funds (\$81, 571) have been carried into the 2022 budget. An additional amount of \$107,538 was also budgeted in 2022. This combined funding will offset expenses related to completing the LiDAR acquisition for the SNC area, project management, and field verification of the data provided by the acquisition vendor. The project is included in the 2022 Budget under Approvals: Projects: Imagery Acquisition on pages 64-65.

ADHERENCE TO SNC POLICY:

<u>SNC Policy Adherence</u>: Expenditures adhere to the SNC Purchasing Policy. Any purchases in the amount of \$25,000 or greater will be brought to the Board for approval.

All field work associated with the above-mentioned programs and projects adheres to SNC's Health and Safety Policy and Procedures.

Attached is an Overview of the Conservation Authorities Act Phase 2 Regulatory and Policy Proposal Consultation Guide which was released by the Ministry of Environment, Conservation and Parks (MECP) on the Environmental Registry of Ontario last week for a 30 day consultation period.

It appears that the Ministry's proposal is building upon what is already working between conservation authorities and municipalities and that there is sufficient flexibility to enable local circumstances to best advise the approach taken to the budget and levy process. This approach is reinforced by some transparency and oversight measures. Conservation authorities are encouraged to consider in their own review of this Consultation Guide whether there is anything missing or included in the proposal that will limit your current practices to a significantly negative degree.

Overview of *Conservation Authorities Act* Phase 2 Regulatory and Policy Proposal

This document represents a summary of the Phase 2: <u>Regulatory and Policy Proposal</u> <u>Consultation Guide: Regulations regarding Municipal levies, Conservation Authority Budget</u> <u>Process, Transparency, and Provincial Policy for the Charging of Fees by Conservation</u> <u>Authorities.</u> This summary provides best advice based on available materials and current understanding of the proposed regulations. This document may be subject to change upon the release of the Phase 2 regulations.

Part 1: Proposed Municipal Levies Regulation

There are 3 basic components being addressed in the proposed regulation: 1) levy: incorporation of the two current levy regulations and updated as appropriate; 2) inclusion of standards and policy for the authority budget process; and 3) apportionment methods for the 3 categories of programs and services that CAs deliver. The update to the levy regulation proposes to retain the two existing voting methods and the three current methods of apportioning expenses/costs. For the budget process, the MECP are proposing to regulate the current process and practices including those for voting. In addition, authorities would be required to provide a summary of how the authority considered opportunities for self-generated revenue as part of the budget to the Minister in addition to its participating municipalities. There are no new apportioning methods proposed. CAs are able to levy for all category 1 (mandatory) programs and services and can only levy for category 2 and 3 programs and services with agreements in place with the municipalit(ies). Corporate administrative costs could be levied without agreement however it is proposed that these costs would be accounted for in a transparent and stand-alone manner in the authority's budget.

Part 2: Proposed Minister's Regulation for Determining Amounts Owed by Specified Municipalities

MECP is proposing a Minister's regulation for determining amounts owed by specified municipalities designated under the *Clean Water Act* and the *Lake Simcoe Protection Act*. These are municipalities that are not a 'participating municipality' of a CA under the *Conservation Authorities Act*. For the levy of 'specified' municipalities under the *Lake Simcoe Protection Act*, MECP is proposing that the modified current property value assessment method be the method for apportionment. For the *Clean Water Act*, the MECP is proposing that any of the three existing apportionment methods could be used.

Part 3: Proposal for Minister's Published List of Classes of Programs and Services For Which a Conservation Authority May Charge a Fee

MECP is proposing to proclaim subsection 21.2 of the *Conservation Authorities Act* which will enable the Minister to determine a list of classes of programs and services for which a CA may charge a fee. The Minister is proposing to enable all classes of programs and services (category 1: mandatory; category 2: municipal; and category 3: other) to charge a fee where the user fee principle is appropriate and subject to other conditions. The list of classes of programs and services will replace the list of specific activities that conservation authorities may charge a fee for which has been in place since 1997. In addition, all conservation authorities will be required to create a fee policy and fee schedule.

Part 4: Complementary Proposals To Increase Transparency of Authority Operations

MECP is proposing a complementary amendment to the <u>Transition Plans and Agreements</u> <u>Regulation</u> to enable fees for category 3 (other) programs and services. Should this amendment be enacted, conservation authorities and participating municipalities would be required to include provisions in their cost apportioning agreements if user fees would be established for those programs and services.

A Minister's regulation is also being proposed that would require conservation authorities to maintain a governance webpage. This webpage must include: CA membership and contact information; authority bylaws; draft and final budgets; category 2 and 3 agreements between CAs and municipalities; and a meeting schedule. CAs would also be required to include a notice on their website when it amends or enters into a new agreement with municipalities. The regulation would provide an exception for CA/municipal agreements that relate to procurement processes or portions of agreements that contain commercially sensitive information.
