Subject: Update: SNC Standing Committee Membership

RECOMMENDATION:

The Communications Committee receive and file the SNC Standing Committee Membership update.

DISSCUSSION:

In February 2022, the Board of Directors approved extending 2021 South Nation Conservation (SNC) Standing Committee membership for 2022, with the intention to undertake membership recruitment this fall for the 2023-2024 term (BD-026/22).

Most Committee members have participated on a Standing Committees for over ten years and are familiar with SNC and its programs and services. Committee member connections to various stakeholder groups is key in building support for ongoing delivery of programs and services (e.g., private landowner stewardship) as SNC transitions to new requirements under the amended *Conservation Authorities Act*.

Staff are preparing a work plan for municipal engagement on SNC programs and services, which will be brought to the Committee at their November 2022 meeting, the support of Standing Committee members is especially important with the upcoming Municipal election, as new Councillors may not be familiar with SNC and its landowner stewardship initiatives.

As such, the SNC Board of Directors has approved maintaining current Standing Committee memberships into 2023. While a formal call for Committee membership would not occur until 2023, the Executive can address any individual requests that are submitted in the interim.

Subject: Update: 2022 Youth Fish Camp Program

RECOMMENDATION:

That the Communications Committee receive and file the 2022 Youth Fish Camp report.

Further that, the Communications Committee recommend that the Board of Directors approve a fee of \$75 per participant for a 2-day Youth Fish Camp in 2023.

DISCUSSION:

In 2022, SNC hosted six separate Youth Fish Camps at four locations: High Falls in Casselman, Jessup's Falls in Plantagenet, Cass Bridge in Winchester and new this year, the Legion Park in Cardinal. Each 2-day camp ran from 9:00 am to 3:00 pm and included 18-20 participants per camp.

The camps were instructed exclusively by SNC staff, with local Councillors assisting at the new camp in Cardinal. The Ottawa Flyfisher's Society also attended this camp.

Participants were asked to bring their own lunches and SNC provided additional drinks and snacks throughout the day, resulting in cost-savings compared to previous years.

Youth were only provided with a fishing rod if they did not have their own or if it was their first-time fishing. This resulted in additional cost savings.

Youth Fish Camps Program Summary:

Number of Participants (6 Camps)	110 youth
Approximate SNC Staff Time for Camp Delivery (3-4 staff/12 camp days)	336 hours
Total Revenue Program sponsorship (\$500) and participant fees (\$40/youth)	\$3,735.52
Total Expenses (75 fishing rods, tackle, supplies, snacks)	\$2,122.63
Net Proceeds / Staff Time Recovery	\$1,609.89





The 2022 participant fee of \$40 helped to offset some of the costs of the camps and assists in deterring last-minute cancellations. Most camps were sold out within 2 days, with the last camp in Jessups Falls and Cardinal selling out within 2 weeks.

Considering the waitlists and demand for these camps, along with the requirement for education programs to be cost recovered, staff recommend increasing the participant fee to \$75 in 2023. Staff also recommend considering an application which would allow reduced rates for participants to address any financial barriers for low-income families.

Staff recommend hosting six summer camps in 2023 and recommend increasing camp capacity to 30 participants at each camp, with approximately 4 staff per camp.

The recommended increase in camp capacity is based on the following:

- 13 years of experience delivering the camps.
- Increased space made available on Conservation Area shorelines.
- Rotational schedule established in 2021 (two groups per camp).
- Ontario Camp Association guidelines of 1 staff per 10 campers ages six and over.

A report will be brought back to the Communications Committee in 2023 to set the location and schedule of the camps, pending approval of the 2023 SNC Budget.

FINANCIAL IMPLICATIONS/ADHERENCE TO SNC POLICY:

<u>Compliance with Budget</u>: Youth Fish Camps are included in the 2022 SNC Budget under Communications and Outreach – Education and Events on page 86 and 87.

Subject: Update: Humble Beginnings Brewery Partnership

RECOMMENDATION:

That the Communications Committee receive and file the update on the Humble Beginnings Brewery Partnership.

DISCUSSION:

South Nation Conservation (SNC) partnered with Humble Beginnings Brewing Co. to create a signature charity beverage for SNC's 75th Anniversary this year: the Green Side Up Lime and Ginger Radler was the perfect creation for hot summer days.

On Wednesday, August 24th, 2022 staff hosted a launch party at the brewery to celebrate the new radler. Tickets for the Radler Launch Party were \$7.50 at the door, which contributed to approximately \$400 which will be allocated to fundraising efforts. Humble Beginnings donated a 12 oz beverage for every ticket purchased.

A portion of proceeds from the signature charity radler (400 L) that Humble Beginnings created will go directly toward SNC's Forest Conservation Initiatives. \$0.50 per 16 oz glass and \$1.00 per 20 oz glass will be directly donated back to SNC, which may contribute between \$400-700, depending on the size of glasses sold. Humble Beginnings has also offered to donate tips made on orders that contain the radler to our Tree Planting Programs, which is estimated at an additional \$500.

DISCUSSION:

In March 2020, the Communications Committee approved amendments to SNC's Community Environmental Grants Program to allow applications for tree and shrub planting and community garden development in response COVID-19 related event cancellations (CMN-036/20).

The following applications for the amended Community Environmental Grants Program have been received:

Eco East

Eco East is a community environmental organization, the mission is leading the community towards a sustainable future for all through volunteer action, community partnerships and education by inspiring a love and respect of nature.

Eco East is working with the Township of Russell Public Library who built an 80 foot by 50 foot garden in the green space beside the Public Library. When completed, the garden will include: in-ground rows for annual crops, raised beds for senior volunteers, two children's experimental areas, a native perennial garden area with fruit trees and pollinator friendly plants, a composting area, a tool shed and a few benches to sit on and enjoy the garden. A three-foot wood and wire fence will enclose the garden and a small gate will welcome volunteers.

Funding from this grant, if awarded by SNC, will be used to assist in purchasing fruit trees for the garden.

<u>Community Environmental Grant Application – Tree Planting</u>

Eco East Russell Library Community Garden Tree Planting 2022

Eco East is a community environmental organization. Our mission is leading the community towards a sustainable future for all through volunteer action, community partnerships and education by inspiring a love and respect of nature. We are a volunteer-run organization. In the spring of 2021, we planted over 700 tree seedlings on private properties in the Russell/Embrun area. We partnered with SNC and Russell Township to plant a tree at the Russell Dog Park last fall. We are also giving away trees on donation this spring at various community events.

This spring, the Township of Russell Public Library built an 80 foot by 50 foot garden in the green space beside the Public Library. When completed, the garden will include: in-ground rows for annual crops, raised beds for senior volunteers, two children's experimental areas, a native perennial garden area with fruit trees and pollinator friendly plants, a composting area, a tool shed and a few benches to sit on and enjoy the garden. A three-foot wood and wire fence will enclose the garden and a small gate will welcome volunteers.

As a community project, the garden welcomes volunteers of all ages and will serve as an educational tool for children and youth.

Through programming and partnerships, everyone who participates in this community project will benefit by gaining a better understanding of how to grow their own food, local sustainable practices, and the benefits of healthy eating. Participants will also establish positive relationships with other volunteers and a sense of belonging by contributing to this community project.

Funding provided by SNC will be used for the purchase of fruit trees for the garden.

Location: Russell Library, 1053 Concession St, Russell, ON K4R 1E1

Additional funding: Eco East and the Russell Library

Project Partners: Eco East, Pick, Plant and Prune, Russell Library

Timing: The garden has been established in spring 2022. Trees to be planted as soon as possible or fall 2022.

Tree species: A mult-fruit (plum/apricot) tree and two others to be determined. It was discussed at our working group meeting that a small fruit tree that is self-pollinating is the better option. As well, the food bank doesn't receive many small fruits and the rest will feed the birds.

Public health measures: All public health measures in place at the time of planting will be followed by all Eco East and Russell Library volunteers as well as contractors working on this

project. This includes social distancing of 2m, mask-wearing where social distancing is not possible, and limiting the number of volunteers present at any one time, if necessary.
