#### **RECOMMENDATION:**

#### **DISCUSSION:**

Ontario's municipal elections take place on October 24<sup>th</sup>, 2022. The results of the election will determine the composition of the South Nation Conservation (SNC) Board of Directors over the next four-year term.

Board Members John Hunter, Archie Mellan, and François St. Amour are retiring from their current municipal council roles. SNC thanks them for their dedication and service.

The watershed's upper tier municipalities (the "Municipalities") make appointments to the Board of Directors in accordance with the *Conservation Authorities Act* and Order in Council 316-96. The appointments are:

City of Ottawa 4 appointments
Stormont Dundas Glengarry 3 appointments
Prescott Russell 3 appointments
Leeds Grenville 2 appointments

Current Board Members retain their seat and participate on the Board until their municipality appoints a replacement. The Municipalities are expected to make new appointments between November 2022 and March 2023.

Of note, the United Counties of Leeds and Grenville appointments are set on a rotational schedule. The upcoming term will be one appointment from Augusta and one appointment from North Grenville.

Recent amendments to the *Conservation Authorities Act* require at least 70% of Board appointments by an individual municipality be members of municipal council. The Board of Directors currently has three public member appointments. Going forward, the City of Ottawa is the sole municipality that can appoint a public member without needing an exception from the province.

If a municipality wishes to appoint a public member, they must apply for an exception from the province. Staff will be reaching out to municipalities and will provide the necessary documents for the application should they wish to appoint non-municipal council members.

Guidelines for Minister's Zoning Orders

#### **RECOMMENDATION:**

The Board of Directors approve amendments to South Nation Conservation's Section 28 Regulations Policies that establish policies and ecological compensation guidelines for permits issued for development projects authorized by Minister's Zoning Orders.

#### **DISCUSSION:**

The *Planning Act* grants the Minister of Municipal Affairs and Housing (the "Minister") the ability to issue Minister's Zoning Orders ("MZOs") under section 47 of the *Planning Act* to control the use of land and permit development projects. Ninety-two MZOs have been issued since April 2019, primarily in the Greater Toronto Area. The Minister has indicated an MZO will only be issued where the local municipal council supports the proposed development.

In December 2020, the province amended the *Conservation Authorities Act* requiring conservation authorities issue permits for development projects that are subject to MZOs (s. 28.0.1). In addition, provisions require the permit holder enter into and agreement with the conservation authority that sets out the actions the permit holder must complete to compensate for ecological impacts and any other impacts that may result from the development project.

The proposed amendments to South Nation Conservation's Section 28 Regulation Polices will help ensure the organization is prepared should an MZO development project be announced in the jurisdiction.

The regulation policy amendments adhere to the statutory and regulatory framework for conservation authority permits that must be issued for MZO development projects. The ecological guidelines would help guide staff to negotiate the mandatory ecological compensation agreement. Any ecological compensation agreement would be brought to the Board for approval.

#### **RECOMMENDATION:**

#### **DISCUSSION:**

South Nation Conservation (SNC) staff are very successful in obtaining funding from external sources (e.g., government, industry, and non-governmental organizations) to support the Authority's programs and projects.

When submitting funding requests, SNC staff target applications to projects already in the Authority's work plan to maximize opportunities to offset program or project costs. When cost-share is required by a funder, SNC utilizes staffing and other resources included in the Budget as the matching contribution. Cost-share ratios vary depending on the funding agency.

Staff often do not hear back regarding applications until months after the submission deadline; this time lag means approved funding may not be reflected in the Budget at time of Budget approval. These funds are partially accounted for in the Federal and Provincial Grants Budget schedule.

For the Board's information, a summary of approved grants from 2018-2022 is attached.

#### FINANCIAL IMPLICATIONS/ADHERENCE TO SNC POLICY:

<u>Compliance with Budget</u>: This report has no impact on budget, provided for information purposes. Unbudgeted revenue offsets SNC levy requirements and typically accounts for the majority of year-end surplus.

Subject: Request for Approval: Russell Erosion Contract

#### **RECOMMENDATION:**

The Board of Directors approve hiring a contractor to complete shoreline erosion repair on East York Creek at an approximate cost of \$55,000 plus HST.

#### **DISCUSSION:**

SNC has a service agreement in place with the Township of Russell to manage an erosion control project on East York Creek in Embrun (BD-128/22). The Township and SNC have identified three sections of shoreline along the creek on Township property as priority for erosion repair, with the first section being addressed in 2022.

The service agreement includes completing the design for the erosion repair, hiring a suitable contractor to complete the work, and completing necessary inspections to ensure the work is completed as per the design.

Staff have finalized the engineered design, received approval on the design from the Township of Russell and have prepared an RFQ for the construction. The RFQ was distributed to five companies that have suitable experience in shoreline erosion control work. Construction is anticipated for November 2022.

#### FINANCIAL IMPLICATIONS/ADHERENCE TO SNC POLICY:

<u>Compliance with Budget</u>: This project is not included in the 2022 Budget. It is 100% cost recovery from the Township of Russell.

<u>SNC Policy Adherence</u>: Selection of the contractor will be made in accordance with SNC Purchasing Policy page 4 subsection (C) (iv): Purchases \$25,000 up to \$100,000.
