#### **DISCUSSION:**

The South Nation Conservation (SNC) Board of Directors held its annual election of officers at the March 2024 Annual General Meeting. Pierre Leroux, United Counties of Prescott and Russell, was appointed Past Chair of the Board of Directors, replacing prior Past Chair George Darouze, City of Ottawa (BD-045/22).

Mr. Leroux has accepted a position with a municipality and is in the process of resigning his term as Mayor of the Township of Russell. The United Counties of Prescott and Russell will be appointing a replacement representative to the SNC Board in the near future.

The appointment of Past Chair ensures continuity of corporate knowledge in the event of a significant change in Board representation following a municipal election cycle.

It has been past practice to appoint the previous Past Chair in the event the current Past Chair is unable to serve out their term. Mr. Darouze was the immediate prior Past Chair from April 2022 to March 2024.

#### DISCUSSION/ADHERENCE TO BUDGET:

South Nation Conservation (SNC) delivers many program and special projects on behalf of its member municipalities and partner organizations. SNC has provided program coordination and financial management for many of these programs for years.

This report provides a breakdown for each program/special project and its associated funds.

#### 1. Eastern Ontario Water Resources Program (EOWRP)

SNC has delivered the EOWRP (formally Eastern Ontario Water Resources Committee) on behalf of its partners since 2003. Several EOWRP projects were approved in 2023 and will be completed in 2024; encumbered funding has been carried forward to the 2024 EOWRP budget.



EOWRP included in 2024 SNC budget under Resource Management: Partner Programs: Water on pages 20-21. Special projects have a separate budget sheet as per below.

#### a) UCPR Floodplain Mapping Project

The United Counties Prescott and Russell (UCPR) is providing \$25,000 in 2024 to support floodplain mapping projects within UCPR's jurisdiction. Project included in the 2024 SNC budget under Approvals: Projects: Natural Hazard Mapping on pages 58-59.

#### b) City of Ottawa: Advancing Early Warning Tools in the SNR Watershed

The City of Ottawa provided \$25,000 to the Advancing Early Warning Tools in the SNR Watershed; a total of \$11,257 was spent, the remainder (\$13,743) has been carried forward to complete the project in 2024. Project included in the 2024 SNC budget under Approvals: Projects: Bear Brook Watershed Study, pages 70-71.

## c) City of Ottawa: Modelling Water Systems on Farms in the Bear Brook Watershed

The City of Ottawa provided \$15,000 to the Modelling Water Systems on Farms in the Bear Brook Watershed; a total of \$2,000 was spent, the remainder (\$13,000) has been carried forward to complete the project in 2024. Project included in the 2024 SNC budget under Approvals: Projects: Bear Brook Watershed Study, pages 70-71.

## 2. UCPR Woodlot Advisory Service (WAS)

The United Counties of Prescott and Russell (UCPR) is providing \$20,000 for the delivery of WAS in their Counties. The funding will focus on grants of up to \$500 for woodlot owners to have a forest management plan developed by a qualified consultant. SNC has delivered the Woodlot Advisory Service in UCPR for the past twelve years. Funding is included in 2024 SNC budget under Resource Management: Partner Programs: Forests on pages 18-19.

## 3. SDG Woodlot Advisory Service (WAS)

The United Counties of Stormont, Dundas and Glengarry (SDG) is providing \$20,000 for the delivery of WAS in their Counties in 2024. The funding will cover free site visits to woodlot owners by a forest technician, grants of up to \$500 for forest management plans, and communications and outreach for the service. SNC has delivered the Woodlot Advisory Service in SDG since 2018. Funding is included in 2024 SNC budget under Resource Management: Partner Programs: Forests on pages 18-19.



## 4. City of Ottawa Special Levy Programs

SNC delivers several programs on behalf of the City of Ottawa and in partnership with the Mississippi Valley (MVCA) and Rideau Valley (RVCA) Conservation Authorities. These programs are funded via a special levy from the City of Ottawa.

These Programs are included in the 2024 SNC Budget under Resource Management: Partner Programs: Forests on pages 18-19 (Ottawa Tree Replacement Program) and Resource Management: Partner Programs: Water (Ottawa Rural Clean Water Program) on pages 20-21. Please note, 2024 Budget amounts do not include 2023 carry over of encumbered grant funds to be paid in 2024.

A separate report for 2024 City of Ottawa Special Levy funding will be brought to the Board in May 2024 pending final approval by City Council.

#### a) Ottawa Tree Replacement Program

The Tree Replacement Program was developed and launched in 2018. The Program provides cost-share funding for landowners to remove trees affected by invasive species (e.g., Emeral Ash Borer) or damaged by extreme weather events (e.g., May 2022 derecho storm) and replace them with native trees. The Program is delivered City-wide by SNC on behalf of the City, MVCA, and RVCA.

Approved projects from 2023 have until June 30, 2024 to be completed, a total of \$86,852 has been carried over from 2023 for projects. This amount includes unencumbered grant dollars which will be allocated to new projects in 2024.

#### b) Ottawa Rural Clean Water Program

Approved projects from 2023 have approximately one year from date of approval to be completed, a total of \$283,568 has been carried over from 2023 projects. This amount includes unencumbered grant dollars which will be allocated to new projects in 2024.

SNC has delivered the Program, in partnership with RVCA and MVCA, since it started in 2000. As the Program lead, in addition to financial administration, SNC provides coordination for delivery, Program Committee meetings, and communications between the Program partners.



## ADHERENCE TO SNC POLICY:

<u>SNC Policy Adherence</u>: Expenditures adhere to the SNC Purchasing Policy. Any purchases in the amount of \$25,000 or greater will be brought to the Board for approval.

#### **RECOMMENDATION:**

The Board of Directors approve the purchase of a Crossover-type vehicle to an upset limit of approximately \$30,000 plus HST; and

FURTHER THAT: The Board of Directors approve disposal of a surplus vehicle.

#### **DISCUSSION:**

South Nation Conservation (SNC) endeavours to provide a safe, economical, environmentally friendly, and practical fleet to meet the needs of all departments. Vehicles are maintained and serviced regularly to maximize life cycles. Acquisition date, mileage, depreciation, and maintenance records are used to develop a replacement schedule for the SNC vehicles.

Following the vehicle replacement schedule, staff recommend the purchase of a new vehicle and disposal of a vehicle at end-of-life cycle. Staff have obtained quotes from local dealers based on available in-stock vehicles and municipal/fleet pricing.

Crossover-type vehicles have proven adequate to meet the equipment and passenger needs of multiple SNC programs including the septic program.

In addition, staff recommend that the Board approve disposal of a 2015 Chevrolet Equinox. The vehicle is nine years old, and the odometer reading is over 255,545 kilometers.

#### FINANCIAL IMPLICATIONS/ADHERENCE TO SNC POLICY:

Compliance with Budget:

Vehicle purchase is included in the 2024 SNC Budget: Vehicles and Equipment, pgs 40-41.

A vehicle transfer to the Septic Program is included in the 2024 SNC Budget: Approvals, Sewage System Reviews: \$20,000, pgs 52-53. Vehicle cost for the septic program are recovered through user fees.

#### **RECOMMENDATION:**

The Board of Directors approve the renewal of the Authority's insurance with Marsh Canada at an upset limit of approximately \$173,624.20 including taxes.

#### **DISCUSSION:**

South Nation Conservation (SNC) is part of Conservation Ontario's group insurance program with most other Conservation Authorities. The insurance provider is Marsh Canada Limited.

SNC's 2024-2025 insurance premium of \$161,499, plus Provincial Sales Tax, represents a 5.1% increase from the previous year. In 2023 the increase was 5.3%.

As our insurance broker, Marsh went to market to ensure the rates paid by the Conservation Authorities are competitive. SNC also performed its own due diligence on the premiums in 2019. At this time staff are confident that SNC's continued participation in the Conservation Ontario group insurance program offers the best value to the Authority.

#### FINANCIAL IMPLICATIONS/ADHERENCE TO SNC POLICY:

<u>Compliance with Budget</u>: Insurance costs are included in the 2024 Budget in the amount of \$188,800 as follows:

- \$164,000 under Corporate Administration (Pages 78 79)
- \$4,000 under Governance (Pages 76 77)
- \$13,300 under Sewage System Review (Pages 52 53)
- \$7,500 under Vehicles and Equipment (Pages 40 41)

Budget includes approximately \$11,500 for additional pollution liability insurance which renews in September 2024.

#### **RECOMMENDATION:**

The Board of Directors approve extending the stormwater management and drainage reviews service contract with Stantec Consulting Ltd. to December 31, 2024, to an upset limit of \$70,000.

#### **DISCUSSION:**

South Nation Conservation (SNC) reviews stormwater management and drainage reports and provides technical advice as part of its provincially delegated role under the *Planning Act* and issuance of permits under the *Conservation Authorities Act*.

SNC occasionally relies on external consulting firms to complete technical reviews when necessary to maintain customer service timelines and for applications where a third-party review is beneficial.

A vacancy in the SNC technical review team necessitated the use of an external consultant. A request for quotes was sent to seven consulting companies with recognized expertise; SNC received three quotes. SNC retained Stantec Consulting Ltd. (Stantec) under a contract with an upset limit of \$25,000. The latest invoice from Stantec exceeded the upset limit and requires retro-active approval.

SNC continues to require some external support for stormwater management and drainage reviews as the volume of reports continues to be steady. Staff recommend an extension to Stantec's contract to an upset limit of \$70,000 until December 31, 2024.

Development review fees provide recovery for review services.

#### FINANCIAL IMPLICATIONS/ADHERENCE TO SNC POLICY:

<u>Compliance with Budget</u>: Technical reviews are included in the 2024 Budget under Approvals: Development Review, pages 46-47.

<u>SNC Policy Adherence</u>: The stormwater management and drainage reviews service contract adheres to clause (C) iv, SNC's Purchasing Policy (purchases \$25,000 up to \$100,000). A request for quotes process was completed for consultant selection.

<u>Program and Services Category</u>: Category 1: Mandatory Programs – Provincially delegated review of natural hazards under the *Planning Act* and administration of Section 28 of the *Conservation Authorities Act* and Ontario Regulation 170/06.
