LOW WATER CONDITIONS IN THE SOUTH NATION RIVER WATERSHED

WATER RESPONSE TEAM ROUNDTABLE - OBSERVED LOW WATER **IMPACTS (VERBAL)**

- Dawn Crump
 - o noted static levels in all wells in North Dundas and North Stormont, North Dundas continue to decline
 - esker wells in North Dundas are especially concerning
 - o manganese levels in the South Nation River at Casselman did increase, to date adjusted treatment as been able to address this
 - o blue green algae could be an issue for Casselman drinking water intake, potential bloom at Crysler weir
- Jacqueline Kelly-Pemberton
 - o beef farmers continue to monitor pasture conditions, may need to decide on whether or not to sell cattle if there is a lack of hay to winter over
 - o dairy farmers no reports to date on any well water issues



- Jason Symington
 - Calls have been received by South Stormont Township for dry well concerns in the Newington area
 - North Glengarry is not permitting water taking from the Garry River system
- Darren Levere
 - o City of Ottawa has no issues with central system with supply from Ottawa River
 - Vars and Shadow Ridge wells are still good, but City is encouraging water conservation
- James Peet
 - Ministry has not received many calls or complaints regarding dry wells
 - Local creeks and rivers are low and in some cases dry
- Pierre Paul Beauchamp
 - Casselman has water ban in effect, manganese issues as per Dawn's earlier comment
- Louis Prevost
 - o Dry conditions across the United Counties of Prescott and Russell
- Terry Otto
 - Big problem is evident when you drive around, very dry everywhere, need to encourage municipalities to take more action
- Todd Lihou
 - Counties posting information on their website provided by SNC, promoting water conservation
- Terrence Sauve
 - Ministry has resources available for agricultural producers on their website, information has been sent to Conservation Ontario to share with conservation authorities

Katherine Watson, Coordinator of Early Warning Systems and Watershed Plans, provided an update on updated map to indicate Level 3 conditions across the SNC jurisdiction. She also provided updates on current communications around low water and possible messaging for requested water use reductions under Level 3.

WATER RESPONSE TEAM ROUNDTABLE - RECOMMENDATIONS (VERBAL)

With the declaration of Level 3 Low Water Conditions, the Water Response Team recommended the following to be included in a memo to municipalities:

- Consider implementing a by-law, or amending current water use by-laws, to prohibits all non-essential water use for residential, commercial, and industrial users.
- Restrictions that reduce peak demand can help maintain adequate pressure for fire protection, protect treatment infrastructure from being overtaxed, and ensure reliable service for essential uses.
- Consider extending seasonal/summer focused by-laws for water use and/or burn bans to remain in effect until the drought conditions improve.
- Promote water conservation messaging to residents serviced by private wells.

RECOMMENDATION:

The Board of Directors approve the revised Record Retention Policy and Schedules as presented.

DISCUSSION:

South Nation Conservation (SNC) maintains a Retention Policy and Schedule to manage records and information created or received by the authority. It is a strategic business resource to support sound decision-making, corporate accountability, and good governance. The policy protects personal and confidential information, while capturing and preserving corporate memory and history.

The purpose is to improve efficiencies, strengthen shared knowledge, and mitigate risk.

The Records Retention Policy applies to all records regardless of format or medium of storage. The policy and schedule ensure that official records no longer needed by the authority are discarded at appropriate times.

SNC manages authority records and information in accordance with various pieces of legislation including: the *Conservation Authorities Act*, the *Municipal Freedom of Information and Protection of Privacy Act*, the *Clean Water Act*, the *Employment Standards Act*, and the *Income Tax Act*.

The Retention Policy and Schedule are drawn from a template prepared by Credit Valley Conservation and was subject to legal review through cost sharing among several conservation authorities, including SNC.

The Record Retention Policy was last updated in December 2012.

A copy of the revised Policy and Schedules will be uploaded to the website prior to the meeting.
