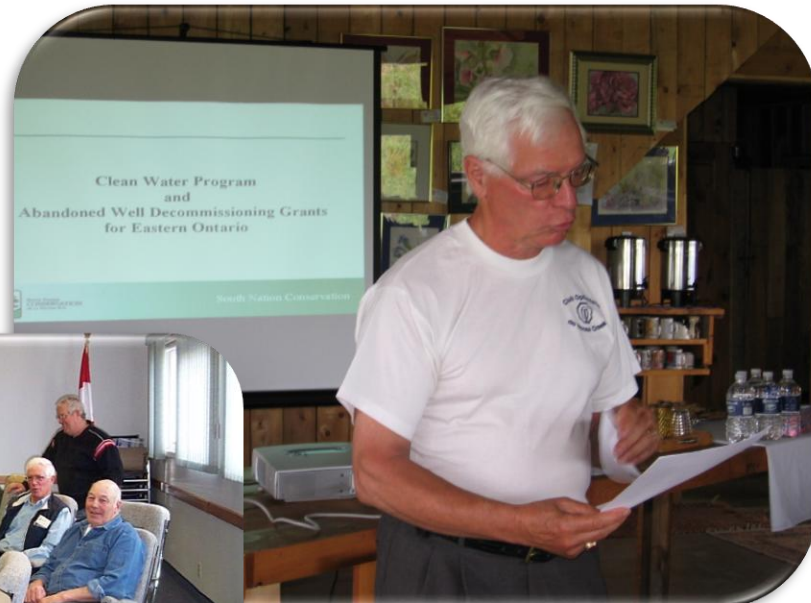

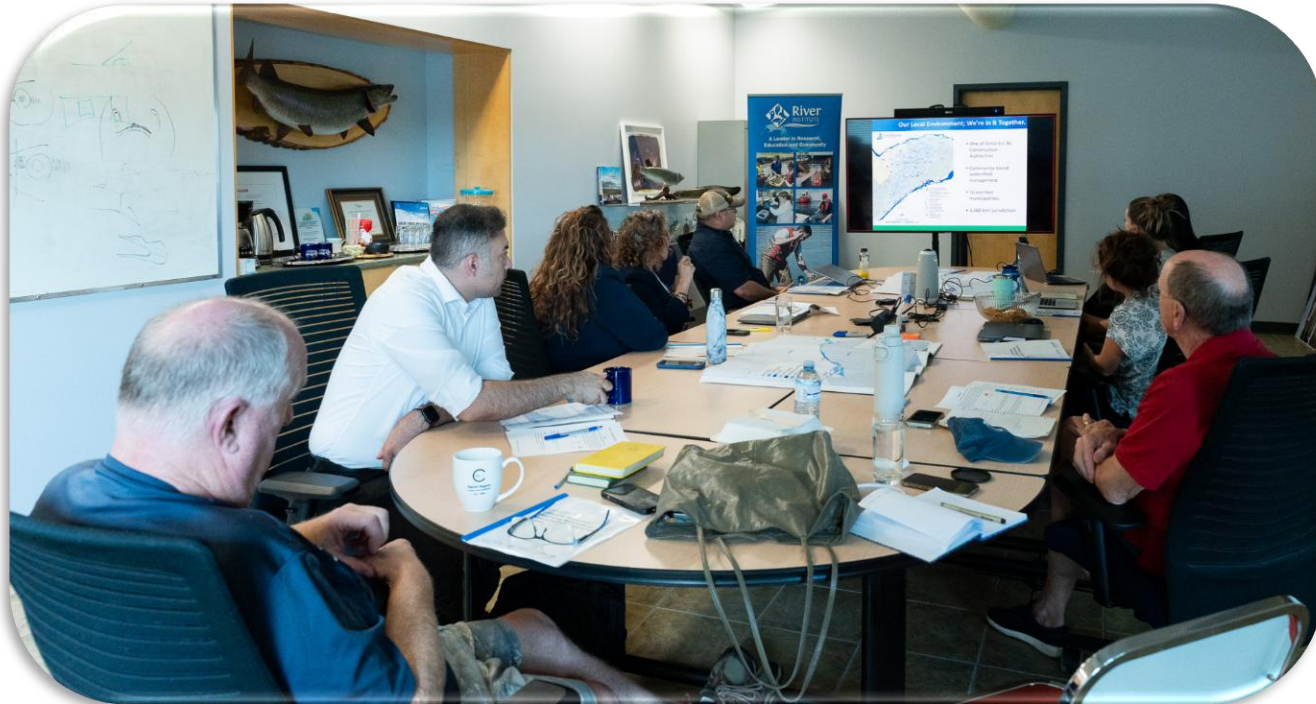

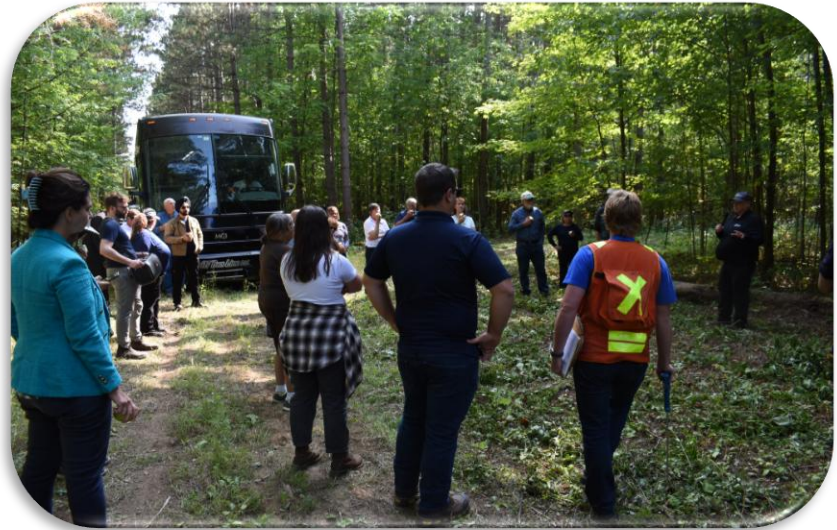
Sharing Expertise: Climate Change Workshop

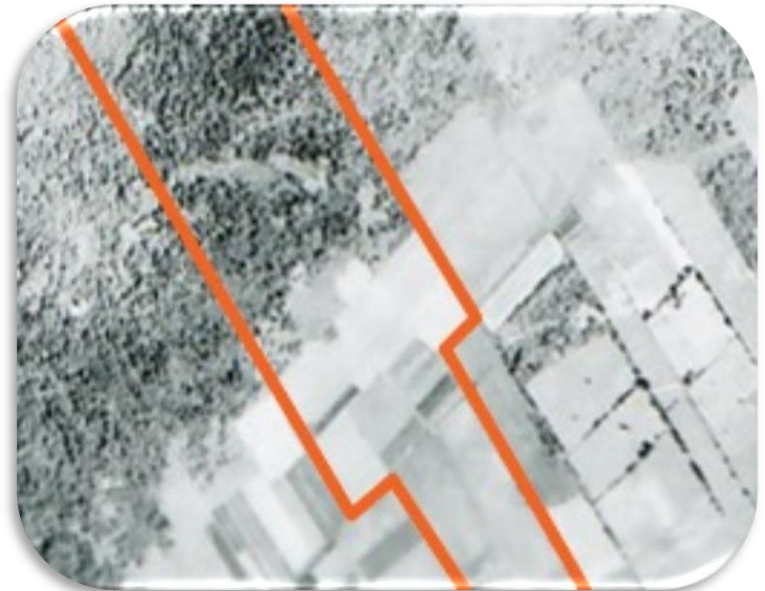


Charleville Creek Wetland Restoration (SNC 188)

- Past land use and soils inform restoration design



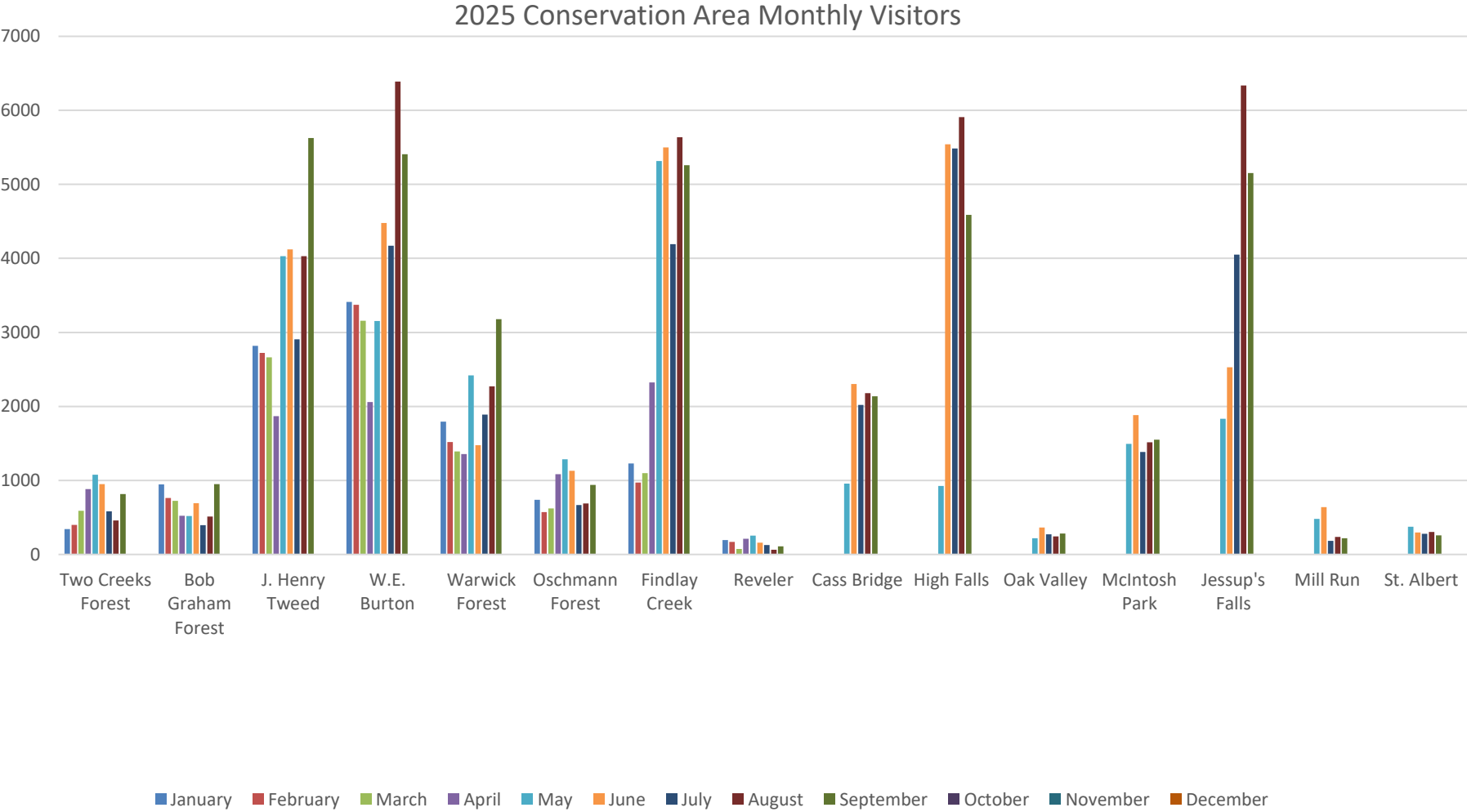
Soil profile, 2025



SNC 188, Augusta Township, 1954

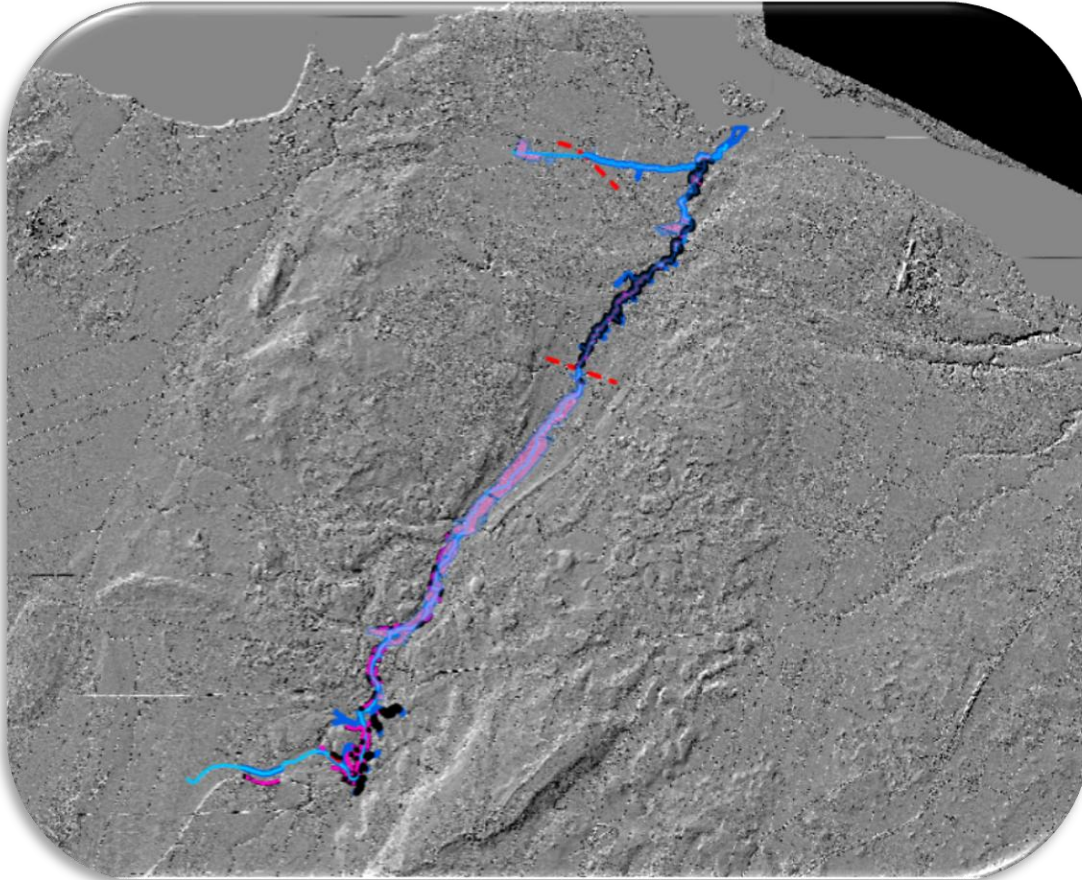
