## Application for Notice to Engage in an Activity in a Vulnerable Area for a Municipal Drinking Water Supply Under Part IV of the *Clean Water Act*, 2006

Under the *Clean Water Act* (the *Act*), a drinking water threat is "an activity or condition that adversely affects or has the potential to adversely affect the quality or quantity of any water that is or may be used as a source of drinking water". The *Act* lists activities that are a drinking water threat if they take place in select areas, under certain circumstances.

The Risk Management Official for the Raisin-South Nation Source Protection Area will review this Application to determine if any activities related to your application can pose a significant risk to the Municipal drinking water source and if any policy(s) in the Raisin-South Nation Source Protection Plan (SPP) apply. The SPP policies manage drinking water threat activities and protect municipal drinking water sources.

By Agreement, South Nation Conservation, as the South Nation Source Protection Authority, acts as an Agent of the Municipality for duties and enforcement under Part IV of the *Act*, for the Regulation of Drinking Water Threats.

- A Notice issued for this Application does not exempt the owner/applicant from complying with other applicable laws, statutes, ordinances, directives, regulations, approvals, etc. as they relate to the activities carried out on the Subject Property.
- If information provided on or with this Application is determined to be untrue or incorrect, or becomes • untrue or incorrect, SNC reserves the right to nullify any prior decisions and issuances based on review of this Application.
- If the Applicant is not the owner of the Subject Property, the Applicant may be required to provide a copy of this Notice or Letter to the owner.
- Further information may be required to process this Application, the costs of which will be borne by the ٠ Applicant.
- Once submitted, all non-personal information related to this Application becomes the property of SNC and may be used by SNC, its' member municipalities, and partners.
- Members of the public may view studies, plans, reports and issuances related to this Application by submitting a formal request under the Municipal Freedom of Information Protection and Privacy Act, RSO 1990, c. M. 56. Access is subject to statutory exemptions.
- Insufficient information may delay the processing of this Application.
- The Risk Management Inspector may enter the Subject Property for the purpose of obtaining information ٠ and monitoring any approved works as authorized under the A ct.
