Terms and Conditions for Hunting Permits

- 1. All hunters must provide proof of minimum \$2 million liability insurance for their hunting activities prior to obtaining hunting permission letter. E.g. (Ontario Federation of Anglers and Hunters Membership, or other insurer).
- 2. It is the hunter's responsibility to ensure they are in compliance with the requirements set forth by Federal, Provincial, and Municipal laws, including those specifically regulating hunting activities.
- 3. Hunters are not permitted to hunt on properties outlined in the "No Hunting" portion of their permission letter.
- 4. No motorized vehicles are permitted on any property owned by SNC at any time.
- 5. Tree stands and blinds must be portable and must be removed by January 14th. Tree stands may only be used between September 15th and January 14th. All other structures are prohibited. SNC assumes no responsibility for tree stands, blinds, or other equipment left on the Authority's property and has the right to remove tree stands after the set period.
- 6. Absolutely no cutting of trees, saplings or branches for access or shooting lanes.
- 7. Camping is not permitted on any SNC property.
- 8. All hunters are required to carry their SNC hunting permission card or letter with them when hunting on SNC property.
- 9. All hunters are required to hang/display SNC permission tags on vehicle, stands and blinds.
- 10. Trap and target shooting, or any other use of a firearm or bow, not related to the act of hunting is strictly prohibited.
- 11. This permit does not convey any trapping rights. The hunter must not interfere with existing trapper activities.
- 12. Any hunter caught in violation of the rules above may result in the hunter's recreational privileges being suspended for the rest of the hunting season and/or the hunter not receiving a hunting permit in the future. Failure to comply with any and all parts of this document may result in loss of hunting privileges and possible intervention from the Ontario Provincial Police and/or Conservation Officer Ministry of Natural Resources and Forestry.
- 13. SNC reserves the right to suspend hunting activities for any reason including, but not limited to: allowing SNC staff and contractors to work safely on the properties, for the safety of the public; or for the conservation of wildlife.
