South Nation Conservation (SNC) is an environmental agency established under the *Conservation Authorities Act of Ontario* with a mission to manage natural occurrences, natural resources, and human activities to protect and improve water resources.

Working on behalf of 16 municipalities in Eastern Ontario, SNC issues land use permits and provides services related to severances, land development, new construction, and inspections of private sewage systems. Privately owned sewage systems, including septic tanks and leaching beds, require a permit for installation or alteration under the Ontario Building Code. Proper operation and maintenance of private sewage systems are also required under this Code.

South Nation Conservation (SNC) enforces Part 8 – Sewage Systems – of the Ontario Building Code through agreement on behalf of the following municipalities:

- City Clarence-Rockland;
  - Alfred-Plantagenet;
  - Town of Hawkesbury;
  - East Hawkesbury;
  - Casselman;
  - Champlain;
  - Russell;
  - Nation;
  - City of Cornwall;
  - North Dundas;
  - North Stormont;
  - South Dundas; and
  - South Stormont.

As a result of the Leeds, Grenville & Lanark District Health Unit's decision to discontinue the delivery of septic services in the United Counties of Leeds and Grenville, SNC had been approached by several municipalities to deliver this service on their behalf, including the municipalities of:

- Edwardsburgh/Cardinal;
- Elizabethtown-Kitley; and
- Augusta.

**Septic system contractors are encouraged to drop in to meet with SNC Septic Officials to learn more about program updates, permit fees, project timelines, and updates to the Ontario Building Code.**

Information will be shared on SNC's Septic System Program including Safe Septic Inspections that are delivered through the *Clean Water Act*, as a requirement in the Raisin-South Nation Source Protection Plan, which requires that septic systems in vulnerable municipal drinking water protection areas be pumped and inspected by a qualified professional every 5 years.

SNC staff look forward to connecting with contractors to discuss program delivery. Light refreshments will be available.
